**ORDINANCE NO. 503**

**An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.**

WHEREAS, A Petition has been filed with the governing body of the City of Willmar, a Municipal Corporation in the State of Minnesota by the sole owners and all persons having any interest therein, to have certain real property, hereinafter described, included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of 3.7 acres described as follows:

Beginning at a point on the W. line of the SE $\frac{1}{4}$  of Sec. 11 and its intersection with the N. R/W line of State Ave., thence Easterly along the N. R/W of State Ave. to a line which is 300' East of and parallel to the W. line of the SE $\frac{1}{4}$  of Sec. 11; thence Northerly parallel to said quarter line to a point on the Southerly R/W line on T.H. 71, thence Westerly along the South R/W line of T.H. 71 to the W. line of the SE $\frac{1}{4}$  of Sec. 11, thence Southerly along said quarter line to point of beginning.

NOW THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Annexation. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The area above described shall be zoned Business Commercial.

Section 5. Effective Date. This ordinance shall be final and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota,




