

AMENDMENT NUMBER ONE

That Chapter Four (4) of the existing charter of the City of West Saint Paul be amended by adding thereto a section to be numbered thirty-three (33), which said section when adopted shall read as follows, to-wit:

The Common Council of the City of West Saint Paul, Dakota County, Minnesota, shall have the power and authority to contract with the City of St. Paul, Ramsey County, Minnesota, or any other adjoining municipality for an outlet to any sewer system installed or to be installed within the City of West Saint Paul, and to pay the necessary cost thereof as is hereinafter provided.

Whenever in the judgment of the common council the capacity of any sewer system of the adjoining municipality shall become inadequate to carry the sewerage turned thereinto and it becomes necessary to enlarge the same the City of West Saint Paul shall be and it is hereby authorized to enter into a contract with the said municipality to pay an equitable proportion of the cost of enlarging such system or systems and to pay the cost thereof in the first instance out of the permanent improvement revolving fund of the city, which said fund shall be replenished by an assessment to be used in the manner hereinafter set forth.

The Common Council of the City of West Saint Paul is hereby authorized and directed to levy an assessment upon and against property in the City of West Saint Paul deemed benefited by said sewer and against any property drained into or which may thereafter be drained into or be served by the said sewer in proportion to the benefits ~~there~~ accruing to each lot or parcel of land deemed benefited thereby respectively, and the common council shall in each instance by resolution determine <sup>whether</sup> ~~the~~ the procedure prescribed in the

charter for making assessments of benefits in the City  
of West St. Paul, or the procedure prescribed by any  
general law shall be followed.

AMENDMENT NUMBER TWO.

That chapter six (6) of the existing charter of the City of West Saint Paul be amended by adding thereto section 52-~~2~~, which said section shall read as follows, to-wit:

ASSESSMENTS - HOW PAYABLE. At the same time that the common council as here-in-before provided shall ratify any assessment it shall in such resolution determine and provide in what number of installments not to exceed ten (10) installments, the assessment against any lot, part, or parcel of land shall or may be paid. Provided, however, that any assessment upon any lot, part, or parcel of land amounting to ten (\$10) dollars, or less, for said lot, part or parcel shall be paid in but one payment.
