ORDINANCE No. 136

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA

WHEREAS, A certain Petition, dated the 30th day of November, 1968, and requesting annexation to the City of Waconia of certain territory described below, was duly presented to and filed with the Common Council of the City of Waconia, pursuant to Minnesota Statutes, Section 414.03; and

WHEREAS, The Council finds that said Petition was signed by all of the owners of said land and was duly verified by them; and

WHEREAS, Copies of said Petition were filed with the Municipal Commission of the State of Minnesota, the Town Board of the Town of Waconia, Carver County, Minnesota, and the County Board of Carver County, Minnesota; and

WHEREAS, More than 30 days have elapsed since the dates of said filings and no objections have been made in writing, or otherwise, to the City of Waconia as to the annexation proposed by said Petition:

THE COMMON COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts the present corporate limits of the City of Waconia; that said lands are unplatted and do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government; and that annexations of said land would be to the best interests of the City of Waconia and of the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

That part of the North Half of the Northeast Quarter ($\frac{N}{2}$ of $NE\frac{1}{4}$) of Section Twenty-four (24), Township One Hundred Sixteen (116) North, Range Twenty-five (25) West, lying South of the right of way of the M. & St. L. Ry. Co., excepting therefrom 11.17 acres described as follows: Commencing at the southeast corner of the Northeast Quarter of the Northeast Quarter ($NE\frac{1}{4}$ of $NE\frac{1}{4}$), Section 24, Township 116 North, Range 25 West; thence running West on the Half Quarter Line 24 chains; thence North $49\frac{3}{4}$ degrees East 3 chains; thence North 67 degrees East 1 chain; thence North $89\frac{1}{2}$ degrees East 4.23 chains; thence South $84\frac{1}{2}$ degrees East 13.15 chains to range line; thence South on said line 4.53 chains to place of beginning, said tract of land to be annexed also being described as that part of the North Half of the Northeast Quarter ($\frac{N}{2}$ of $NE\frac{1}{4}$) of Section 24, Township 116, Range 25, lying Southerly of the right of way line of the M. & St. L. Ry. Co., which is bound on the West by the North-South Center Line of Section 24, on the South by the Waconia township road which runs Easterly from Carver County Road No. 10 through the North Half of said Section 24 to the East Line of said Section 24, and on the East by the east line of said Section 24.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of the certified copies of this Ordinance as directed in Section 3.
