Notary Public, Lyon County, Mich. My Commission Expires Sept. 24, 1959 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota, by the sole owner of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

All that part of the Southwest Quarter of Section 33, Township 112 North, Range 41 West of the 5th Principal Meridian in Lyon County, Minnesota that is within the following described boundaries; beginning at a point as follows:

Commencing at the Southwest corner of Section 33, thence East along the South line of said Section 1179 feet, thence North 45 Degrees, 41 Minutes East along the Centerline of the Township Road as there now laid out and maintained 685 feet to the point of beginning; thence in a Northwesterly direction at right angles to said Centerline a distance of 160 feet, thence Northeasterly at right angles parallel with said Road 200 feet, thence Southeasterly at right angles 160 feet to the Centerline of said Road, thence Southwesterly along said Centerline 200 feet to the point of beginning, subject to existing highway rights of way.

LESS THE FOLLOWING DESCRIBED REAL ESTATE to-wit:

All that part of the Southwest Quarter of Section 33, Township 112 North, Range 41 West of the 5th Principal Meridian in Lyon County, Minnesota that is within the following described boundaries:

Commencing at the Southwest corner of said Section 33, thence Easterly along South line of said Section 33, on an assumed bearing of North 89 Degrees, 42 Minutes, 30 Seconds East, a distance of 1179 feet, thence North 45 Degrees, 41 Minutes East along the center line of the Township Road as established and maintained through said Section 33, a distance of 992.9 feet, thence Due West a distance of 148.14 feet, to point of beginning, thence North 43 Degrees 14 Minutes West a distance of 58.53 feet, thence South 46 Degrees, 46 Minutes West a distance of 62.25 feet, thence due East to a point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described, is 0.08 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 4. Therefore, the City of Marshall, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if it had originally been a part hereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
