ORDINANCE NUMBER 107 VILLAGE OF FOLEY BENTON COUNTY MINNESOTA

WHEREAS, a certain petition dated August 9, 1968, requesting annexation of the teritory hereinafter described was suly presented to the Council on the ninth day of August, 1968; and

WHEREAS, the quantity of land appraised within the area described in the petition and bounded as described is approximately 3.17 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits;

THE COUNCIL OF THE VILLAGE OF FOLEY MINNESOTA ORDAINS AS FOLLOWS:

That the 1967 Code of Ordinances of the Village of Foley be amended by adding Chapter Ten, Section 100:02 to read as follows:

Section 100:02 (1).

The Village Council hereby determines (1) that the annexation will be to the best interest of the Village and to the territory affected; (2) that the territory described herein abuts upon the village limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 100:02 (2) Territory Annexed.

CORNER All that part of the Southwest Quarter of the Southwest Quarter (SW4 of SW4), Section Twenty-five (25), Township Thirty-seven (37), Range Twenty-nine (29) West, described as: Beginning at the Southwest (SW) Quarter of Wildman and Tauer's Addition to the Village of Foley, thence, south along the section line a distance of 290.0 feet to a point; thence east and parallel to the south line of Wildman and Tauer's Addition for a distance of 475.8 feet to a point; thence, north 290.0 feet to a point, said point being the southeast corner of said Addition, thence, west 475.8 feet along the south line of said Addition to a point, which point is the point of beginning of the tract herein described, said tract containing 3.17 acres, more or less, which is of record in the name of DONALD D. WRUCK AND KAREN M. WRUCK, husband and wife as joint tenants.

Section 100:02 (3) Filing.

Section 100:02 (4) Effective Date.

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 100:02 (3).
