ORDINANCE NO. 64

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN LANDS TO THE VILLAGE OF EVANSVILLE, MINNESOTA, AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND.

WHEREAS, Evansville Developers, Inc., has filed with the Village Council a Petition requesting that the hereinafter described lands lying in the County of Douglas, State of Minnesota, be annexed to the Village of Evansville, and further requesting that the corporate limits of the Village of Evansville be altered to include said lands, and

WHEREAS, The Village Council of the Village of Evansville has examined said Petition and has found that Evansville Developers, Inc., is the sole owner of said property; that said property is contiguous to the existing boundaries of the Village of Evansville; and that said land is occupied by the Evansville Nursing Home and its residents, and

WHEREAS, The Village Council of the Village of Evansville has caused copies of said Annexation Petition to be filed with the Evansville Township Board, the Douglas County Auditor and the Minnesota Municipal Commission, and that no objection to said annexation has been received from any of said parties within thirty (30) days of the date of said filing, and

WHEREAS, The Village Council of the Village of Evansville, Minnesota, finds that the property set forth in said Petition is so conditioned as to be properly subjected to municipal government and, further, that the annexation of said lands would be in the best interests of the municipality and the territory affected and to be annexed.

NOW, THEREFORE, The Village Council of the Village of Evansville does ordain:

SECTION I. That the following described land is hereby annexed to and made a part of the municipality of the Village of Evansville, Minnesota, and the corporate limits of the Village of Evansville, Minnesota, shall be and are hereby extended to include and encompass the land and territory described as follows, to-wit:

A part of Government Lot Three (3) in Section Three (3), Township One Hundred Twenty-nine (129) North, Range Forty (40) West of the 5th P.M., and more particularly described as follows, to-wit: To find the point of beginning commence at the Northwest corner of Block Four (4) of the Original Townsite of Evansville; thence following the Southerly line of State Street thus: North $81^{\circ}11'$ West 581.90 feet; thence North $82^{\circ}14'$ West 630.0 feet; thence South $89^{\circ}46'$ West 126.20 feet to the point of beginning; thence from the point of beginning and continuing on last said course South $89^{\circ}46'$ West 73.80 feet; thence leaving said South line of State Street South $01^{\circ}26'30''$ East 282.10 feet; thence South $83^{\circ}54'$ East 72.66 feet to the intersection with the North-South quarter line of said Section Three (3); thence North $01^{\circ}05'$ West and along said quarter line 290.50 feet to the point of beginning and containing 0.48 acre; and also all that part of State Street extended which lies North of and adjacent to the above described tract.
