ORDINANCE NO. 449

AN ORDINANCE ANNEXING UNPLATTED LANDS  
TO THE CITY OF BEMIDJI PURSUANT TO  
MINNESOTA STATUTES 1965, SECTION 414.03,  
SUBDIVISION 2.

WHEREAS, A petition has been filed with the City Clerk on July 26, 1968, signed by all of the owners of the lands described therein praying that said lands be annexed to the City of Bemidji,

AND, WHEREAS, Proof has been presented to the City Council establishing that the said petition was served on the Town Board for Bemidji Township and the Board of Commissioners for Beltrami County wherein such lands described are located, and on the Municipal Commission of the State of Minnesota, said service on all of said governmental units and agencies having been made prior to July 31, 1968,

AND, WHEREAS, Thirty days from and after July 31, 1968, have elapsed and no written objections to the said annexation having been made to the City of Bemidji or to the Municipal Commission,

NOW, THEREFORE, THE CITY OF BEMIDJI DOES ORDAIN:

1. That the City Council of Bemidji, Minnesota, does hereby determine that annexation into the City of Bemidji of the lands described in said petition and herein described as follows:

That part of Northwest Quarter of Southwest Quarter (NW 1/4 of SW 1/4) lying north and east of the Minnesota and International Railway right of way (now known as the Northern Pacific Railway Company), Section Twenty-two (22), Township One Hundred Forty-six (146), Range Thirty-three (33);

All of Northeast Quarter of Southwest Quarter (NE 1/4 of SW 1/4), Section Twenty-two (22), Township One Hundred Forty-six (146) Range Thirty-three (33);

That part of Northwest Quarter of Southeast Quarter (NW 1/4 of SE 1/4) lying south and west of Great Northern Railway Company right of way, Section Twenty-two (22), Township One Hundred Forty-six (146) Range Thirty-three (33);

That part of Southeast Quarter of Southwest Quarter (SE 1/4 of SW 1/4), and that part of Southwest Quarter of Southeast Quarter (SW 1/4 of SE 1/4) lying southwest of right of way of Northern Pacific Railway Company (formerly Minnesota and International Railway Company), less and excepting therefrom the Westerly 210 feet of Southerly 400 feet thereof, all in Section Twenty-two (22), Township One Hundred Forty-six (146), Range Thirty-three (33);

Southeast Quarter of Southwest Quarter  
(SE 1/4 of SW 1/4), Section Twenty-two (22),  
Township One Hundred Forty-six (146), Range Thirty-  
three (33), less that part lying southwest of the  
right of way of Northern Pacific Railroad Company;

Southwest Quarter of Southeast Quarter  
(SW 1/4 of SE 1/4), Section Twenty-two (22),  
Township One Hundred Forty-six (146), Range Thirty-  
three (33), less that part thereof lying southwest of  
right of way of Northern Pacific Railroad Company;

That part of Southeast Quarter of Southeast Quarter  
(SE 1/4 of SE 1/4), Section Twenty-two (22), Township  
One Hundred Forty-six (146), Range Thirty-three (33),  
lying southwest of Great Northern Railway Company  
right of way;

will be to the best interests of the City of Bemidji and of the lands and  
territory affected.

2. That the said lands described herein are hereby  
annexed by and into the City of Bemidji and that the proper city and other  
government officers are hereby authorized and directed henceforth to amend,  
revise or remake all plats showing the geographical confines of the City  
of Bemidji to include as a part thereof the lands hereby annexed.


3. This ordinance shall take effect and be enforced from


