CHAPTER 24

Ordinance No. 24

An ordinance providing for the annexation of certain land abutting the village, upon petition of all of the owners of such land.

THE VILLAGE COUNCIL OF COKATO, MINNESOTA, ORDAINS:

Section 1.

That pursuant to a petition by all of the owners of certain property which is unplatted and is less than 200 acres, and which is abutting the corporate limits of the village of Cokato, and described as follows:

The Southeast Quarter of the Southwest Quarter  
(SE1/4 of SW1/4) Section 34, Township 119, Range 28

the Village Council has unanimously determined that it is to the best interests of the village and to the best interest of the property to be annexed, that it be annexed.

Section 2.

That said petition was duly filed with the Clerk of the Village of Cokato, with the Town Clerk of the Town of Cokato, with the Board of Commissioners of Wright County, Minnesota, and with the Municipal Commission of the State of Minnesota, more than thirty days prior to the date of adoption of this ordinance.

Section 3.

The tract hereinbefore described is, by this ordinance, declared to be annexed to the Village of Cokato.

Section 4.

This ordinance shall take effect upon its passage and publication and upon the filing of a copy of this ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
