An ordinance amending Section 203 of the Saint Paul City Charter.

The Council of the City of Saint Paul Does Ordain:

SECTION 1

Pursuant to Ex. Sess. Laws 1967, Chapter 33, and upon recommendation of the Charter Commission of the City of Saint Paul, the Charter of the City of Saint Paul is hereby amended to read as contained herein.

SECTION 2 '

Section 203 of said Charter is amended to renumber the present Section 203 as 203.1.

SECTION 3

There are hereby added to said Section 203 Sections 203.2, 203.3, 203.4, and 203.5, to read as follows:

"203.2. Revision within adopted budget. By resolution adopted by the affirmative vote of six of its members the Council may plake adjustments to the adopted budget to increase or decrease any appropriation item in any amount, within the estimates of available revenues adopted as part of the original budget. Such resolution shall not be adopted until after a public hearing for which five (5) days' public notice shall be given once in the official newspaper of the City of Saint Paul, and approval by the City Comptroller, which approval shall be endorsed on said resolution.

"203.3 Increase, in, adopted budget. If, pursuant to Section 75, the Comptroller shall report that new or additional revenues have been received or will be received in excess of the estimates of available revenues adopted with the original budget, the Council may, by resolution adopted by the affirmative vote of six of its members, increases any appropriations in the original or amended budget by an amount not in excess of the new or additional revenues.
