ORDINANCE NO. 74

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

WHEREAS, a petition for annexation of lands hereinafter described duly signed by all of the owners of land prepared for annexation has been filed with the Village Council of the Village of Stewartville;

AND WHEREAS, copies of said petition have been filed with the Minnesota Municipal Commission, the High Forest Town Board and the Clasted County Board;

AND MHERELS, more than thirty (30) days have elapsed since the filing of the copies of said setition with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board, and no written objections to the proposed annexation have been filed with the Village of Stewartville;

AND WHEREAS, the petition was signed by 100% (1) owners of the land proposed for annexation, no public hearing is required;

AND WHEREAS, The Village Council of Stewartville, Minnesota, has determined that the annexation will be to the best interest of the Village of Stewartville and territory affected;

THE VILLAGE COUNCIL OF STEWA TVILLE, MINNESOTA, DOES ORDAINS

1. The following described lands are hereto annexed and made a part of the Villege of Stewartville, to-wit?

That part of the Southeast Quarter(SE¹/₄) of Jection Thirty-three(33) in Township One hundred Five North (105N) of Range Fourteen West (14W) lying east of the center line of the Root River and creek and which abutts on the east the following described property:

Commencing on the west line of the Southwest Juarter (SW1) of Jection Thirty-four (34) in Township One hundred Five North (105N) of Range Fourteen West (14W) at a point which is one hundred seventy-one(171) feet south of the south line of Wooldridge's Jecond Highland Addition to the Village of Jtewartville, for a point of beginning; thence east six hundred seventy-five (675) feet and nine-tenth(9/10) feet to a point which is twenty-five (25) feet west of the southwest corner of Lot Fifty-three (53), Wooldridge's Second Highland Addition to the Village of Stewartville; thence southerly at a deflection angel of eighty-seven (87) degrees and twenty-five (25) and five-tenths (5/10) minutes for a distance of eight hundred eighty-three (883) and three-tenths (3/10) feet; thence north eighty-eight (88) degrees fifty-six (56) minutes west to the west line of the Jouthwest Quarter (SW1) of Jection Thirty-four (34); thence north on the section line to the point of beginnings
