ORDINANCE N. 75

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

WHEREAS, the land being annexed is owned by the Village no public hearing is required;

AND WHEREAS, the Village Council has determined that the annexation will be to the best interest of the Village and territory effected;

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA DOES ORDAIN:

1. The following lands are hereto annexed and made a part of the Village of Stewartville, to-wit:

Beginning about five (5) rods east of the Southwest (SW) corner of the East one-half ( $E\frac{1}{2}$ ) of the Southeast quarter ( $SE\frac{1}{4}$ ) of section twenty-seven (27), thence East seventeen (17) rods to the Chicago-Great Western Railway right-of-way thence North twenty (20) rods along the Chicago-Great Western right-of-way, thence West twenty-three (23) rods to Root River, thence Southwesterly along said river seven (7) rods, thence South to the place of beginning. Ten and one-half rods ( $10\frac{1}{2}$ ) all in township 105 Range 14 West.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.
