

ORDINANCE NO. 507

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, The following described land is owned by the City of Willmar, Minnesota, and whereas the said property abuts upon the City and is so conditioned as to be properly subject to city government and since annexation thereof will be to the best interests of the City of Willmar and of the territory to be annexed,

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar, as follows:

Section 1. Annexation. The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

Parcel 1: The South Half of the Southwest Quarter of the Northwest Quarter of Section 17, Township 119 North and Range 35 West, all in Kandiyohi County and containing approximately 20 acres.

Parcel 2: The South 330 feet of the Southeast Quarter of the Northwest Quarter of Section 17, Township 119, Range 35 and that part of the Southeast Quarter of the Northwest Quarter of said section lying between the Center line of County Ditch No. 10 and a line 330 feet North of and parallel with the South line of the Southeast Quarter of the Northwest Quarter of said section, all in Kandiyohi County, Minnesota, Approximately 12.2 acres.

Parcel 3: That part of the Northwest Quarter of the Southwest Quarter, Section 17, Township 119, Range 35 lying North and West of the center line of County Ditch No. 10 located in the Northwest Quarter of the Southwest Quarter of said Section 17, containing 3.5 acres more or less, and That part of Northwest Quarter of the Southwest Quarter of Section 17, Township 119, Range 35 described as follows, to-wit: Beginning at the Northeast Corner of said Northwest Quarter of the Southwest Quarter, thence South along the East line of said Northwest Quarter of the Southwest Quarter to a point 650 feet North of the Southeast Corner of said Northwest Quarter of the Southwest Quarter, thence Northwesterly along a line, (which line if projected Northwesterly would intersect the West line of said Northwest Quarter of the Southwest Quarter a distance of 150 feet South of the Northwest Corner thereof), to the Center line of County Ditch No. 10 located in said Northwest Quarter of the Southwest Quarter, thence Northeasterly along the Center line of said County Ditch No. 10 to a point where the Center line of said Ditch intersects the North line of said Northwest Quarter of the Southwest Quarter, thence Easterly along the North line of the said Northwest Quarter of the Southwest Quarter to the Northeast Corner thereof, being the point of beginning, containing 8.8 acres more or less.

Section 2. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota and of the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to city government.

Section 4. Zoning. The area above described shall be zoned Farm Residence.

Section 5. Effective Date. This ordinance shall take effect and be in full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of the State of Minnesota and from and after its passage and publication.

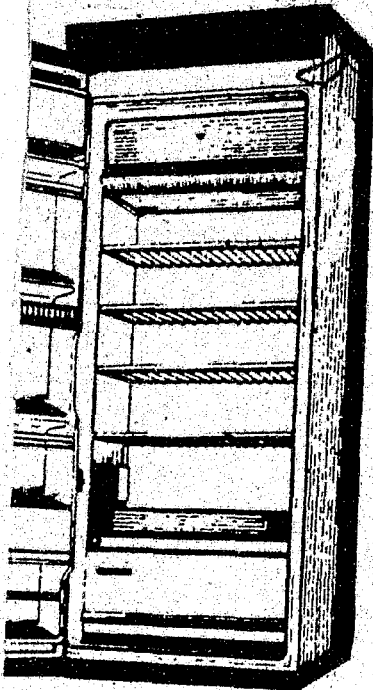
