ORDINANCE NUMBER 111
VILLAGE OF FOLEY
BENTON COUNTY MINNESOTA

WHEREAS, a certain petition dated June 17, 1969, requesting annexation of the territory hereinafter described was duly presented to the Council on the 1st day of July, 1969; and

WHEREAS, the quantity of land appraised within the area described in the petition and bounded as described is approximately 3/4th of an acre in size and is unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits;

THE COUNCIL OF THE VILLAGE OF FOLEY MINNESOTA ORDAINS AS FOLLOWS:

That the 1967 Code of Ordinances of the Village of Foley be amended by adding Section 100:03 to read as follows:

Section 100:03 (1).

The Village Council hereby determines (1) that the annexation will be to the best interest of the Village and to the territory affected; (2) that the territory described herein abuts upon the village limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 100:03 (2) Territory Annexed.

The Corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

Part of the Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section Thirty-five (35), Township Thirty-seven (37) North, Range Twenty-nine (29) West, described as follows: Commencing at a point on North line of Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section Thirty-five (35), Township Thirty-seven (37) North, Range Twenty-nine (29) West, said point being 1,209.02 feet West of Northeast (NE) corner thereof; thence East on said North line 42.04 feet; thence deflect right 62 $^{\circ}$ 00' a distance of 11.33 feet; thence East parallel to said North line of Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), a distance of 18.65 feet for point of beginning; thence East parallel to North line of said Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), 74.70 feet; thence South at right angles 167.81 feet; thence deflect right 85 $^{\circ}$ 03' a distance of 74.98 feet; thence deflect right 94 $^{\circ}$ 57' a distance of 174.28 feet to point of beginning, and;

Part of Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), of Section Thirty-five (35), Township Thirty-seven (37) North, Range Twenty-nine (29) West described as follows: Commencing at point on North Line of Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section Thirty-five (35), Township Thirty-seven (37) North, Range Twenty-nine (29) West, said point being 1,209.02 feet West of Northeast corner thereof; thence East on said North line 42.04 feet; thence deflect right 62 $^{\circ}$ 00' a distance of 11.33 feet; thence East parallel to said North line of Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), a distance of 93.35 feet for point of beginning; thence East parallel to North line of said Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), 74.70 feet; thence deflect right 60 $^{\circ}$ 51' a distance of 176.23 feet; thence deflect right 114 $^{\circ}$ 12' a distance of 161.15 feet; thence deflect right 94 $^{\circ}$ 57' a distance of 167.81 feet to point of beginning.

Section 100:03 (3) Filing.

The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission, Secretary of State, and the County Auditor.

Section 100:03 (4) Effective Date.

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 100:03 (3),
