Ordinance Number One Hundred Forty-six (146)

AN ORDINANCE AMENDING ORDINANCE NO. 142 BEING AN ORDINANCE EXTEND-ING THE CORPORATE LIMITS OF THE CITY OF CANBY TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES.

That Section 4 of Ordinance No. 142 is amended so as to read as fol-Section 1. lows:

The corporate limits of the City are hereby extended to include the property described in Section 1, together with the right-of-way of T.H. 68 lying Northeasterly and adjacent to the property described in Section I and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

Section 2. This Ordinance shall take effect upon its passage and publication and the filing of certified copies hereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CANBY TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES.

Section 1. A petition has been filed with the governing body of the City of Canby, Minnesota, by the sole owner of the following described real estate, to have such land included within the City of Canby, Minnesota:

That part of Section Four (4), Township One Hundred Fourteen (114) North, Range Forty-five (45) West, described as follows: Beginning at a point on the Southwesterly line of First Street, City of Canby, extended Northwesterly 20 feet from the Northwest corner of Lot One (1), Block Eighty (80), Swenson's Tenth Addition; thence Northwesterly along said Southwesterly line of First Street extended 1350.0 feet; thence at right angles Southwesterly to the Northeasterly line of the right of way of the Chicago and Northwestern Railway Company; thence Southeasterly along said railway right of way to a point intersecting a line parallel with and distant 20 feet from the Northwesterly line of said Block 80; thence Northeasterly to the place of beginning.

Section 2. The quality of land embraced within the foregoing description does not exceed 200 acres.

Section 3. The City Council hereby determines:

- (1) That the annexation will be to the best interest of the City of Camby, Minnesota, and of the territory affected;
- (2) That the territory described herein abutts upon the city and is so conditioned as properly to be subject to city government.

Section 4. The corporate limits of the city are hereby extended to include the property described in Section 1. and the same is hereby annexed to and included in the city as effectually as if it had originally been a part thereof.

Section 5. The City Administrative Assistant is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 6. This ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 5.
