ORDINANCE NO. 344

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY LOCATED IN THE TOWNSHIP OF LYNN

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Carl Moehring and Herman Larson, being sixty-seven per cent (67%) of the owners of the following described real property, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

The East ninety (90) feet of the West one hundred seventy (170) feet of lot five (5) of the Auditor's Plat of that part of the Northwest Quarter (NW $\frac{1}{4}$) of Section 1 Township 116 North Range 30 West, lying South of the Mill Pond, McLeod County, Minnesota.

The Westerly twelve and one-half (12 $\frac{1}{2}$) feet of lot four (4), and lot five (5) except the West one hundred seventy (170) feet thereof, all being a part of Auditor's Plat of that part of the Northwest Quarter (NW $\frac{1}{4}$) of Section 1 Township 116 North Range 30 West, lying South of the Mill Pond.

All of lots eleven (11), twelve (12), thirteen (13) and fourteen (14) of Auditor's Plat of that part of the Northwest Quarter (NW $\frac{1}{4}$) of Section 1, Township 116 North Range 30 West, lying South of the Mill Pond, McLeod County, Minnesota; all of said lots described in this description are dedicated street right-of-way as intended by said Auditor's Plat, and are being used as such.

Section II. The quantity of land embraced within the foregoing description, and bounded as described, is two and fifty-one hundredths (2.51) acres.

Section III. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section IV. Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section V. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
