*Ordinance No. 2136*  
AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINONA  
TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY  
AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, certain land described below is not presently included in the corporate limits of any incorporated City, Village, or Borough; and

WHEREAS, this land abuts upon the corporate limits of the City of Winona at the Southwesterly boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City;

NOW, THEREFORE, the City of Winona does ordain:

Section 1. The corporate limits of the City of Winona, Minnesota, are hereby extended to include the unplatted land described as follows, now owned by the City of Winona:

Commencing at the Quarter Post between Sections Twenty (20) and Twenty-nine (29), Township One Hundred Seven (107), North, of Range Seven (7); thence west on the section line for a distance of 361.42 feet to the place of beginning of the land to be described; thence North 428.90 feet; thence West 202.74 feet, more or less, to the Easterly boundary line of the Gilmore Valley Creek ditch right of way as established by proceedings in the District Court by the State of Minnesota of record in the office of the Register of Deeds, Winona County, Minnesota; thence Northwesterly along the Easterly boundary of said right of way as so established to the Easterly boundary line of the Trunk Highway No. 14 cutoff right of way; thence Southwesterly along said last described boundary line to the center line of said Gilmore Valley Creek; thence following said center line of said Creek and in a southeasterly direction to a point (which point is 100 feet due North of a point on the South line of said Section Twenty (20) and 500 feet West of the said Quarter Post between said Sections Twenty (20) and Twenty-nine (29)); thence South for a distance of 100 feet; thence East to the place of beginning.

Section 2. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 3. This ordinance shall take effect and be deemed final upon filing said copies as provided for in section 1 hereof.

*Ordinance No. 2137*

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINONA  
TO INCLUDE CERTAIN UNINCORPORATED LAND COMPLETELY SURROUNDED  
BY THE LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain land described below is not presently included in the corporate limits of any incorporated City, Village, or Borough; and

WHEREAS, this land is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

NOW, THEREFORE, the City of Winona does ordain:

Section 1. The corporate limits of the City of Winona, Minnesota, are hereby extended to include the unplatted land described as follows, which land now is and has heretofore been completely surrounded by land already included within the City limits:

Commencing at a point on the South line of Section Twenty (20), Township One Hundred Seven (107) North, of Range Seven (7), West of the Fifth Principal Meridian, 161.42 feet west of the South quarter east of said Section for the place of beginning of the land to be described; thence north 165 feet; thence west 200 feet; thence South 165 feet to the South line of said Section; thence East 200 feet to the place of beginning;

Also, beginning at said South quarter east; thence north 225 feet; thence West 16.5 feet; thence South 225 feet; thence East 16.5 feet to the place of beginning;

Also, commencing at said South quarter East; thence west 99 feet to the place of beginning of the land to be described; thence north 40 feet; thence west 62.42 feet; thence South 40 feet; thence East 62.42 feet to the place of beginning.

Section 2. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 3. This ordinance shall take effect and be deemed final upon filing said copies as provided for in Section 2 hereof.

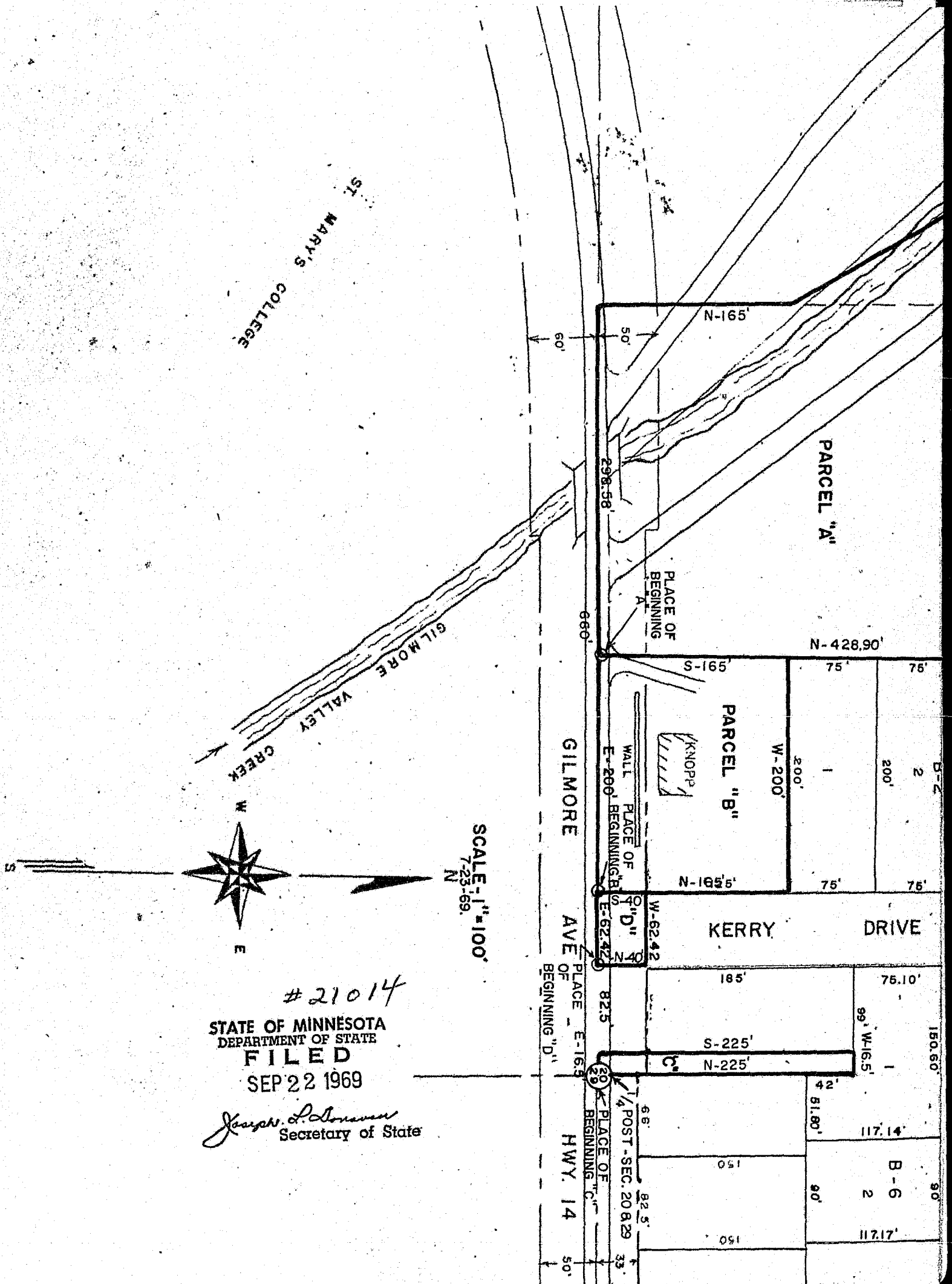

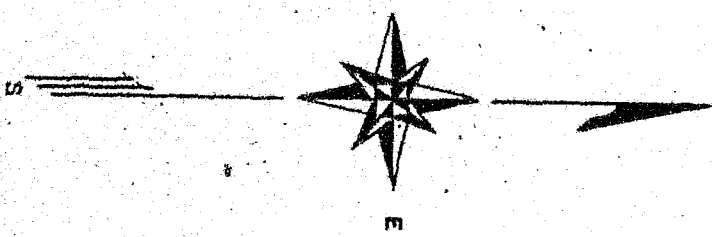

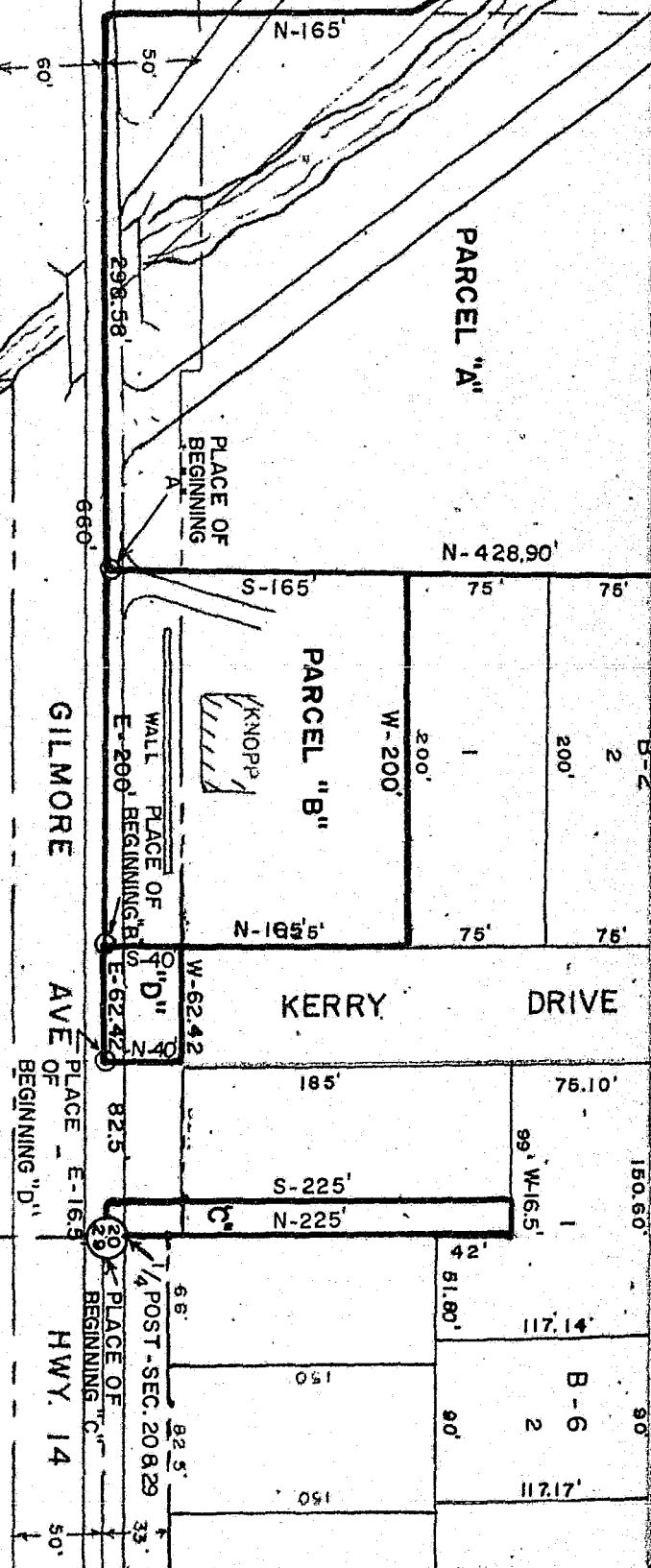

GILMORE AVE OF PLACE OF BEGINNING "D"

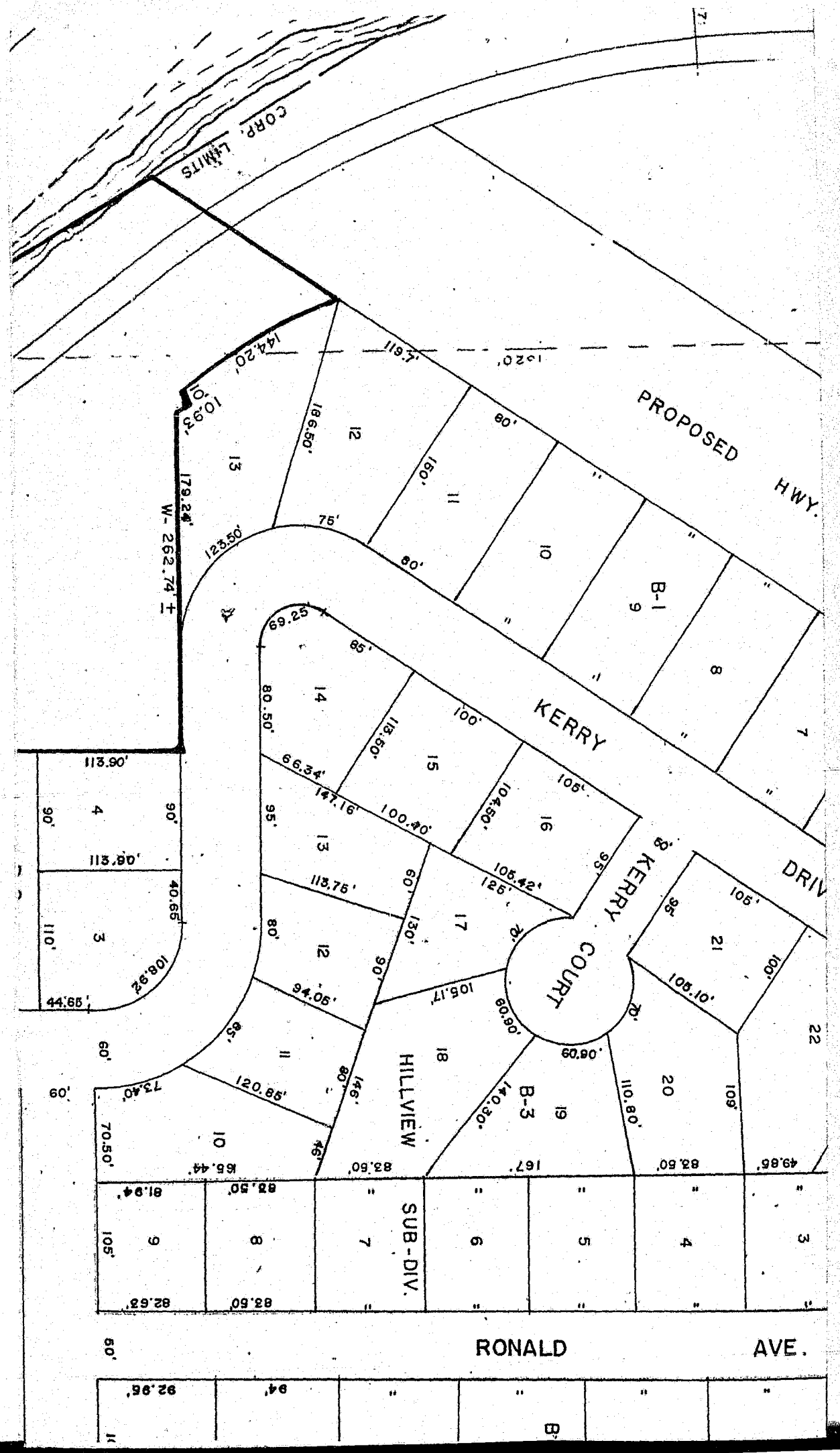

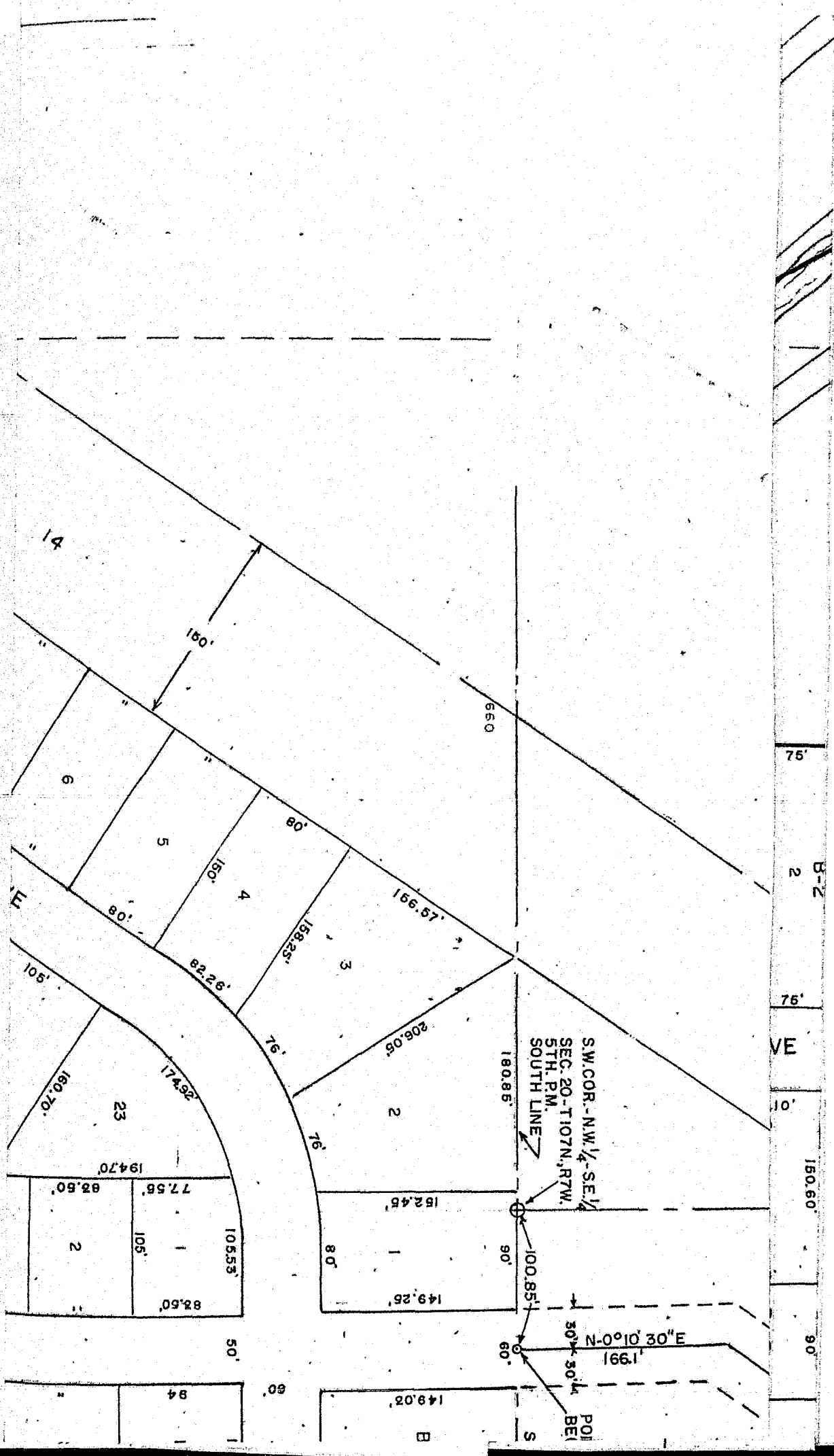
PARCEL "A"
