AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINONA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUITING UPON THE LIMITS OF THE CITY

WHEREAS, certain land described below is not presently included in the corporate limits of any incorporated City, Village, or Borough; and

WHEREAS, this land abuts upon the corporate limits of the City of Winona at the Southwesterly boundary thereof and is deemed to be urban in character; and WHEREAS, this territory is owned in fee by the City;

NOW, THEREFURE, the City of winona does area in:

Section 1. The corporate limits of the City of winana, minnesota, are hereby extended to include the unplatted land described as follows, now owned by the City of winana:

AN URDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDNA TO INCLUDE CERTAIN UNINCORPORATED LAND COMPLETELY SURROUNDED BY THE LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain land described below is not presently included in the corporate limits of any incorporated City, Village, or borough; and

WHEREAS, this land is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

NOW, THEREFORE, the City of Winona does ordain:

Section 1. The corporate limits of the City of Windna, dinnesota, are hereby extended to include the unplatted land described as follows, which land now is and has heretofore been completely surrounded by land already included within the City limits:

Commencing at a point on the South line of Section Twenty (20), Township use Hundred Leven (107) worth, of Range Seven (7), West of the Fifth Principal Meridian, 101.42 feet Lest of the South Quarter Post of said Section for the place of beginning of the land to be described; thence worth 165 feet; thence West 200 feet; thence South 165 feet to the South line of said Section; thence East 200 feet to the place of beginning;






