## ORDINANCE NO. 476

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED TO THE CITY OF NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:

1. That the following described tract of land is bordered on three sides by 75% or more of the municipal boundaries of the City of North Mankato and are platted and urban in character:

A portion of the North one-half of the Northeast Quarter of Section 11, Township 108, Range 27, Described as follows:

Commencing at a point at the center of the county road 167.6 feet north and 76.6 feet east of the southwest corner of the northeast quarter of the northeast quarter of said Section 11; thence west and parallel with the south line of said north one-half of the northeast quarter a distance of 256 feet; thence north 18 feet; thence west 44 feet; thence north 220 feet; thence west 225 feet; thence south 405.6 feet to the south line of said north one-half of the northeast quarter; thence east on said south line a distance of 525 feet, more or less, to the center of the county road and thence northerly along the center of said county road 167.6 feet, more or less, to the point of beginning, together with any and all streets, highways and other public right of ways within and adjacent to said described land, and containing 3.27 acres, more or less.

2. Said above described land is hereby declared annexed to and made a part of the City of North Mankato, Nicollet County, Minnesota, according to Minnesota Statute 414.033, sub. 3.

3. This Ordinance shall take effect from and after its date of passage and publication.
