AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED ON THREE SIDES BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and WHEREAS, the City of Montevideo did on February 25, 1969, give Sparta Township notice of its intention to annex the same to the City of Montevideo; and

WHEREAS, this territory is 75% bordered on three sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

The City of Montevideo does ordain:

<u>Section 1. Territory Annexed.</u> The corporate limits of the City of Montevideo, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been 75% bordered on three sides by territory already included within the city limits:

> A tract of land in the County of Chippewa and State of Minnesota described as commencing at the Northwest corner of the Northeast Quarter of the Northwest Quarter of the Northeast Quarter (NE% of NW% of NE%) of Section Seventeen (17), Township One Hundred Seventeen (117) North, Range Forty (40) West, thence East along the north line of said Northeast Quarter (NE%) a distance of three (3) chains and sixteen (16) links, thence south a distance of three (3) chains and sixteen (16) links, thence west a distance of three (3) chains and sixteen (16) links to the West line of said Northeast Quarter of said Northwest Quarter of said Northeast Quarter (NEt of NWt of NEt), thence Southerly along said East line to its intersection with the extension Easterly of the North line of Lot Nine (9) in Block Two (2) of Oscar Sorby's First Addition to the City of Montevideo, thence Westerly along said extension and along the North line of said Oscar Sorby's First Addition to the City of Montevideo, to the Northeast corner of Lot One (1) in Block One (1) of said Oscar Sorby's First Addition, which point is Ninety-nine (99') Feet West of the West line of the Northwest Quarter of the Northwest Quarter of the Northeast Quarter (NW2 of NW2 of NE2) of said Section Seventeen (17), thence North and parallel to said West line of the Northwest Quarter of the Northwest Quarter of the said Northeast Quarter (NW% of NW% of NE%) to the North line of said Section Seventeen (17), thence East along the North line of said Section Seventeen (17) to the point of beginning, containing 8.0 acres.

<u>Section 2. Filing.</u> The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Effective Date of Annexation. This ordinance takes effect upon Section 3. passage and publication and the filing of certified copies as directed in Section 2.
