AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF GENEVA TO INCLUDE CONTAIN UNINCORPORATED UNFLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUITING UPON THE VILLAGE LIMITS.

VHEREAS, a certain petition dated December 16, 1967, requesting annexation of the territory hereinafter described was duly presented to the council on the lst day of July, 196_{-9}^{-9} ; and

MERRAS, the quantity of land cobraced within the area described in the petition and bounded as described is less than two acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

THEREAS, the petition was signed by all the owners; and

WHEREAS, no objections to the annexation have been received from the townboard, the county board, or the governing body of any municipality whose boun arise abut upon the boundaries of the land to be annesed; and

WHEREAS, the land described in the petition abuts upon the village limits thereof;

The council of the Village of Geneva, Minnesota, ordains:

Section 1. The Village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Intion 2. Territory Annexed. The corporate limits of the Village are extended to include the unplatted land described as follows and the true is hereby annexed to and included within the village as effectually as if it had originally been a part Corpor:

Commencing at the Southeast corner of Block 100, Villageof Geneva, Freeborg County, State of Minnesota: thence East 14 2/7 rods, thence South 1500 feet, thence West 14 2/7 rods, thence North 1508 feet to point of beginning, less the Mollowing tract of land included in the above description now comed by Harold B. Wayne and Patricia Veyne and now being a part of the Village of Genova, Hinnesota: Commencing at the Southeast commer of Lot C, Plock 99, · Village of Geneva, Presborn County, State of Minnesote, thence East 197 fact, thence South 200 feet, thance West 497 lest, thence North 250 feat to point of beginning. And less the Following: Communist at a point & feet South of the Southcast corner of Lat 10, Block 98, Village of Genera, Freehern County, State of Nichtsott, thance East 185 feet, theres sauth 190 feet, themes West 183 feat, thence North 193 fact to paint of beginning.

Commencing at a point 8 feet South of the Southeast corner of Lot 10, Block 98, Village of Geneva, Freeborn County, State of Minnesota: thence East 185 feet, thence South 190 feet, thence West 105 feet, thence North 190 feet to the point of beginning.

Section 3. Filipg. The village clerk is hereby directed to file cortified copies of this ordinance with the Minnesota Municipal Commission,

tion 4. Effective Date. This ordinance takes effect upon its passage in Light and the filing of the certified copies as directed in Section 3.
