ORDINANCE No. 19

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF GENEVA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJUTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated December 16, 1967, requesting annexation of the territory hereinafter described was duly presented to the council on the 1st day of July, 1969; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than two acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, no objections to the annexation have been received from the town-board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits thereof;

The council of the Village of Geneva, Minnesota, ordains:

Section 1. The Village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the area is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

Commencing at the Southeast corner of Block 100, Village of Geneva, Probosc County, State of Minnesota: thence East $14 \frac{2}{7}$ rods, thence South 1505 feet, thence West $14 \frac{2}{7}$ rods, thence North 1508 feet to point of beginning, less the following tract of land included in the above description now owned by Harold E. Wayne and Patricia Wayne and now being a part of the Village of Geneva, Minnesota:
Commencing at the Southeast corner of Lot 9, Block 99, Village of Geneva, Probosc County, State of Minnesota, thence East 197 feet, thence South 230 feet, thence West 197 feet, thence North 230 feet to point of beginning.
And less the following: Commencing at a point 5 feet South of the Southeast corner of Lot 10, Block 99, Village of Geneva, Probosc County, State of Minnesota, thence East 185 feet, thence South 150 feet, thence West 185 feet, thence North 150 feet to point of beginning.

JUL 14 1969

Commencing at a point 8 feet South of the Southeast corner of Lot 10, Block 98, Village of Geneva, Freeborn County, State of Minnesota: thence East 185 feet, thence South 190 feet, thence West 185 feet, thence North 190 feet to the point of beginning.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
