## 1.35 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE

The City Council of the City of Pipestone do ordain as follows:

Section 1. A tract of land in Section 18, Township 106 North, Range 45 West of the 5th P.M., Pipestone County, Minnesota, described by metes and bounds as follows:

All of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Eighteen (18), Township One Hundred Six (106) North, Range Forty Five (45) West of the 5th P.M. lying East of the Rock Island Railway Right of Way, consisting of 123 acres more or less; except a tract of land in said parcel previously annexed which is described as follows: Beginning at a point on the east quarterline of Section Eighteen (Sec. 18), Township One Hundred Six North (TLOGN), Range Forty-five West (R45W) of the Fifth Principal Meridian (5th P.M.), Pipestone County, Minnesota, four hundred thirty-three feet (433.00') west of the east quarter corner of said Sec. 18. Thence south parallel to the east line of said Sec. 18, four hundred seventy-three and forty hundreths feet (473.401); thence turning right 89°451, sixty four feet (64.001); thence turning right 90°00', around an eighty feet (80.00') radius curve, concave southwesterly, and with a central angle of 90°15'; thence west parallel to the south line of said Sec. 18, one thousand one hundred fifty eight and ten hundreths feet (1,158.101); thence turning left around an eighty feet (80.001) radius curve, concave southeasterly, and with a central angle of 115°59'; thence southeasterly parallel to the east right-of-way line of the Chicago, Rock Island and Pacific Railroad and four hundred sixty four feet (464.00\*) distant therefrom, one thousand seven hundred eighty five and sixty hundreths feet (1,785.60'); thence turning left around an eighty feet (80.00') radius curve, concave, northeasterly, and with a central angle of 64011; thence east parallel to the south line of said Sec. 18, fifty four feet (54.001); thence turning right 90000, sixty four feet (64.001); thence turning right 90 00' around an eighty feet (80.00') radius curve, concave southeasterly, and with a central angle of 89°45'; thence south, two hundred forty feet (240.00:) thence turning left around an eighty feet (80.00:) radius curve, concave northeasterly, and with a central angle of 90°15; thence south parallel to the east line of said Sec. 18, thirty three feet (33.001) to the south line of said Sec. 18; thence west on the south line of said Sec. 18, three hundred seventy seven and ten hundreths feet (377.10') to the east right-of-way line of the Chicago, Rock Island and Pacific Railroad, thence northwesterly along the east right-of-way line of the Chicago, Rock Island and Pacific Railroad, two thousand nine hundred fifty and twenty six hundreths feet, (2,950.261) to the east quarter line, of said Sec. 18; thence east, two thousand one hundred thirty five and fifty hundreths feet (2,135.501) to the point of beginning; now owned by the Pipestone Area Development Corporation, containing 86.38 acres, and being contiguous to and abutting on the corporate limits of said city, is hereby declared to be a part of the City of Pipestone.

Section 2. This ordinance shall take effect and be in force from and after its passage and pyblication.
