1.35 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE

The City Council of the City of Pipestone do ordain as follows:

Section 1. A tract of land in Section 12, Township 106 North, Range 46 West of the 5th P.M., Pipestone County, Minnesota, described by notes and bounds as follows:

Commencing at a point on the West line of the Northwest Quarter (17th) of Section Twelve (12), Township One Hundred Six (106) North, Range Forty-Six (46) West of the 5th P.M. where the same is intersected by the Northern line of Chicago, Milwaukee and St. Paul Railway Company right of way, thence running east on the northern line of said right of way a distance of 697.3 feet to the east line of a northerly extension of east line of 6th Avenue N.W. of the City of Pipestone, Minnesota; thence north along the east line of said northerly extension of 6th Avenue N.W. a distance of 251.7 feet to the south line of 4th Street N.W. of the City of Pipestone (formerly Pillsbury Street); thence north to the north line of said 4th St. N.W.; thence east to a point 75 feet west of a northerly extension of the center line of 4th Avenue N.W. of the said City of Pipestone thence north 150 feet; thence east 75 feet; thence north on the northerly extension of the center line of said 4th Avenue N.W. (formerly 2nd Street) about 683 feet; thence east 40 feet; thence north 396.5 feet; thence west about 793 feet; thence north to a point 315 feet south of the north line of said Section 12; thence westward to a point 315 feet south of the northwest corner of said Section 12; thence south along the west line of said Section 12 to the place of beginning; containing in all 54.57 acres more or less. Subject to any easements for street and road purposes and excepting portions heretofore conveyed by parties of the first part or their predecessors in interest and excepting that portion of the premises above described lying south of 4th Street N.W. now owned by Pan-Cold Realty Company, containing 54.57 acres, and being contiguous to and abutting on the corporate limits of said city, is hereby declared to be a part of the City of Pipestone.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.

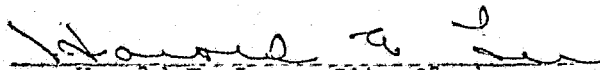
