ORDINANCE NO. 114

AN ORDINANCE ANNEXING CERTAIN UNPLATTED LAND TO THE VILLAGE OF WAITE PARK, IN STEARNS COUNTY, MINNESOTA

WHEREAS, the Village of Waite Park, in Steams County, Minnesota, is the owner of lands situate within the Township of St. Cloud, in Steams County, Minnesota, described as follows, to-wit:

A tract of land lying in and being a part of the SW\(\frac{1}{4}\) NW\(\frac{1}{4}\) Section 17, Township 124 North, Range 28
West, and being bounded by the following described lines; on the north by the centerline of Minnesota Trunk Highway 52 as now constructed and traveled; on the east by the westerly right-of-way line of lith Avenue in Waite Park, Minnesota, on the south by the south line of said NW\(\frac{1}{4}\), on the west by a line lying westerly and 191 feet distant and parallel with the westerly right-of-way line of said lith Avenue in Waite Park,

WHEREAS, M.S.A. Lill, 03 Subdivision 2 authorizes the governing: bodies of municipalities to annex land to said municipality if the samo is owned by said municipality, and,

WHEREAS, said land is urban in character and it is in the best interest of said village that the same be within the corporate limits of said village,

NOW, THEREFORE, the Village Council in and for the Village of Waite Park does hereby declare and ordain;

That the corporate limits of the Village of Walke Park, in Stearns County, Minnesota, be and they hereby are extended to include that certain real estate hereinbefore described, and the same is hereby annexed and included in the Village of Waite Park as effectually as if it had originally been a part thereof.

This ordinance shall become effective from and after its passage and publication.
