ORDINANCE NO. 508

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 2000 Acres.

WHEREAS, the following described land is completely surrounded by the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of 1.7 acres described as follows:

The South 10' of the West 150' of the East 182' of Govt. Lot 2, Sec. 11, T119N, R35W, Co. of Kandiyohi, and the North 290' of the West 150' of the East 182' of Govt. Lot 3, also in Sec. 11, T119N, R35W; and

The South 100' of the North 990' of the West 150' of the East 183' of Govt. Lot 3, Sec. 11, T119N, R35W, Co. of Kandiyohi,

NOW THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interests of City of Willmar. That the

annexation will be to the best interests of, the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Annexation. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The area above described shall be zoned Business Commercial.

Section 5. Effective Date. This ordinance shall be final and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of the State of Minnesota, and from and after its passage and publication.
