AN ORDINANCE ANNEXING CERTAIN LANDS OWNED BY THE INDEPENDENT SCHOOL DISTRICT NO. 637 TO THE CITY OF REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

1. That the following described lands lying and being in the County of Redwood, State of Minnesota,

to wit:

Commencing at the Southeast (SE) corner of Block Nineteen (19) of Sunnyside Heights Addition to the City of Redwood Falls, thence running South 219 feet to the center of County Ditch No. 52; thence Westerly along the center line of said County Ditch No. 52 and Westerly on the extended said center line to a point on the Eest line of McPhail Drive, which is Two Hundred (200) feet due South of the Southwest (SW) corner of Hlock Nineteen (19) of Sunnyside Heights Addition; thence North along the said East line of Mc-Phail Drive a distance of Two Hundred (200) feet to the Southwest (SW) corner of said Block Nineteen (19), thence East along the South line of said Block Mineteen (19) to the point of beginning, said tract being a part of the Southwest Quarter (SW4) of Section Six (6), in Township One Hundred Twelve (112) North, of Range Thirty Five (35) West
