CHAPTER XV.

ORDINANCE NO. 150 - L.

AN ORDINANCE ENTITLED THE COUNCILS LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ADJACENT UPON THE VILLAGE ADDED AND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented and filed with the Village of Sartell on July 30th, 1959; and, WHEREAS the quantity of land annexed within the area described in the petition and bounded as described herein is not in excess of 10.13 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough and,

WHEREAS the petition was signed by all the owners of said land; and,

WHEREAS no objection to the annexation has been received from the South Rapid Township Board, the Benton County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS the land described in the petition abuts upon the Village limits on the South Boundary on the Easterly edge of said Village in Benton County, Minnesota, U.S.A., THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDERING AS FOLLOWS:

Subsection 1. The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

Subsection 2. Territory Annexed. The corporate limits of the Village of Sartell are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village of Sartell as effectually as if it had originally been part thereof, to-wit:

All that part of the Northeast Quarter of the Northwest Quarter (NE<sup>1/4</sup> NW<sup>1/4</sup>) of Section Fifteen (15), Township Thirty-Six (36) North, Range Thirty-One (31), Benton County, Minnesota, described as follows:

PARCEL "A"

Commencing at the Northwest corner of said Section 15; thence in an Easterly direction along the North line of said Section 15 for a distance of 1650.37 feet to the point of beginning; thence continuing along the aforesaid line 462.00 Feet; thence deflect right 91 Degrees 38 Minutes 40 Seconds in a Southerly direction 438.00 feet; thence deflect right 80 Degrees 21 Minutes 20 Seconds in a Westerly direction along a line parallel to the North line of said Section 15 for a distance of 462.00 feet; thence deflect right 91 Degrees 38 Minutes 40 Seconds in a Northerly direction 438.00 foot to the point of beginning and there terminating. Said tract containing 4.33 acres, more or less, and subject to existing road right of way over and across the North boundary thereof. SAID PARCEL BEING ANNEXED UNDER MAXIMUM CLASSIFICATION OF R - 3.

PARCEL "B"

Commencing at the Northwest corner of said Section 15; thence in an Easterly direction along the North line of said Section 15 for a distance of 2112.37 feet to the point of beginning; thence continuing along the aforesaid line 541.63 feet to the North東 corner of said Section 15; thence deflect right 83 Degrees 49 Minutes 20 Seconds in a Southwesterly direction along the East line of said NW 1/4 for a distance of 439 feet; thence deflect right 91 Degrees 10 Minutes 40 Seconds in a Northeastly direction along a line parallel to the North line of said Section 15 for a distance of 968.06 feet; thence North to point of beginning. Said tract containing 5.00 acres, more or less, and subject to an existing road right of way over and across the North boundary thereof.

SAID PARCEL BEING ANEXED UNDER XENITHS CLASSIFICATION OF R - 1

Subsection 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, the Benton County Auditor and the Minnesota Municipal Commission.

Subsection 4. Effective Date of Amendment. This Ordinance will take effect upon the passage and publication and the filing of the certified copies as herein directed.
