FINDINGS OF FACT, CONCLUSIONS OF LAW, ORDER

A petition, having been filed with the Minnesota Water Resources Board, on March 19, 1969, asking for the change of boundaries of the Stockton-Rollingstone-Minnesota City Watershed District, Minnesota City, Winona County, pursuant to the provisions of Minnesota Laws of 1955, Chapter 799, as amended;

And the Board on July 7, 1969, having ordered that a hearing be held on said petition on the 7th day of August 1969 at 8:00 P.M., Central Daylight Time, in the Rollingstone Village Hall, Rollingstone, Minnesota, 55969, and ordering Chairman Putnam to act as a referee to hear the evidence and report it to the Board;

And the Referee having held hearing pursuant to said Order; and, Donn Christensen, Deputy Attorney General, and Erling Weiberg, Administrative Secretary, appearing with the Board's Referee, and Charles Bergh, Attorney, St. Charles, Minnesota, appearing for the petitioners, the managers of said watershed district;

And the Referee having heard testimony and evidence offered on behalf of the petitioners and by interested citizens and having duly reported the same to the Board; and the Board, having considered the same, now makes the following FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER:

FINDINGS OF FACT

I. That a petition, including a map, signed by the qualified managers of the Board of Managers of the Stockton-Rollingstone-Minnesota City Watershed District, was filed with the Board on March 19, 1969, with proof of service substantiating that a copy of the petition was filed with the County Auditor of Winona County, the Commissioner of the Minnesota Conservation Department and the Director of the Division of Waters, Soils and Minerals, all pursuant to law;

- II. That the Stockton-Rollingstone-Minnesota City
 Watershed District was established by Order
 of the Minnesota Water Resources Board approved
 by the Board on December 17, 1958 and dated
 December 26, 1958 with its principal place
 of business at the Village of Minnesota City,
 Winona County, Minnesota;
- III. That the Stockton-Rollingstone-Minnesota City Watershed District territory lies wholly in Winona County;
- IV. That the petition for change of boundaries was found sufficient by the Board on July 7, 1969.

 A hearing was ordered to be held at 8:00 P.M.,

 Central Daylight Time, August 7, 1969 in the Rollingstone Village Hall, Rollingstone,

 Minnesota 55969;
- V. That the Board designated Chairman Putnam as the Board's Referee at the hearing to hear the evidence and report to the Board.
- VI. Due and proper notice was given by publication to the owners of lands hereinafter described:

- VII. That the Referee conducted the scheduled hearing on August 7, 1969 in the Rollingstone Village Hall, Rollingstone, Minnesota 55969, and filed his report on the matter with the Board on August 12, 1969. The report was heard and approved by the Board on August 18, 1969;
- VIII. That the Director of the Division of Waters, Soils and Minerals examined the petition and filed his report on the petition with the Board;
 - IX. That the Director recommended boundaries for said

 District in accordance with the petition with

 certain changes as set forth in his report;
 - X. That in Paragraph XIII of the December 26, 1958

 Order establishing the said District the Board

 defined the boundary by specific townships, ranges

 and sections and by a watershed divide line as

 shown on a map introduced as an exhibit during

 the proceeding for the establishment of the

 watershed district;
 - XI. That the existing boundaries are not definite and certain for the purposes of administration, and are insufficiently described to enable the Auditor of Winona County to levy taxes as authorized by law;

CONCLUSIONS OF LAW

- I. The Minnesota Water Resources Board has jurisdiction over the matter of the change of boundaries of the Stockton-Rollingstone-Minnesota City Watershed District, and has the authority to define and change the boundaries;
- II. That the boundaries of the Stockton-RollingstoneMinnesota City Watershed District based on the
 evidence adduced at the hearing should be defined
 as set forth in the Board's Order herein.
- III. That the public interest and public welfare and
 the purpose of the law, will be served by the
 change of the boundaries as hereinafter set forth;
- IV. That the lands within the boundaries as changed are contiguous and can be feasibly administered by the managers of the established district.

IT IS THEREFORE ORDERED

I. That the territory of Stockton-RollingstoneMinnesota City Watershed District of
approximately 100 square miles, including
all government lots, forty-acre tracts, or
tracts of lesser acreage, and all lots of

platted areas, within the Stockton-Rollingstone-Minnesota City Watershed District, is as described below:
