

(CORRECTION OF ORDINANCE NUMBER ON PUBLICATION NO. 1210 OF SEPTEMBER 10, 1969 - AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON)

ORDINANCE NO. 345

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON

THE CITY OF HUTCHINSON DOES ORDAIN:

SECTION I. WHEREAS, the following described land lying and being in the County of McLeod, State of Minnesota, described as follows, to-wit:

Lot 17 of Auditor's Plat of Section 7, Township 116
North, Range 29 West,

is contiguous to and at least 75 per cent of said land abuts upon the city limits of the said City of Hutchinson and said lands are so conditioned as to be properly subjected to municipal government, and

SECTION II. WHEREAS, the City of Hutchinson has followed and complied with the statutes of the State of Minnesota for the annexation of said land, and

SECTION III. WHEREAS, the City Council of the City of Hutchinson deems it desirable and in the best interest of the City of Hutchinson to annex the said above described lands to the City of Hutchinson.

SECTION IV. NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUTCHINSON, that the lands above described, ^{be} and hereby are annexed to the City of Hutchinson and from and after the date of passage of this ordinance said lands shall become a part and portion of the said City of Hutchinson with the same force and effect as though originally a part thereof.

SECTION V. This ordinance shall take effect and be in force from and after its publication.
