ORDINANCE NO. 191

AN ORDINANCE RELATING TO THE ANNEXATION  
OF AND ANNEXING CERTAIN LANDS TO THE  
CITY OF REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

Section 1. That it has hereby found, determined and declared:

(a) That a petition has heretofore been filed in the Office of the Redwood Falls City Clerk requesting the annexation of the tracts of real estate described in Section 2. of this Ordinance to the City of Redwood Falls.

(b) That more than thirty (30) days prior hereto copies of said Petition for Annexation were filed with the Minnesota Municipal Commission, the Town of Honner and the County of Redwood, and that no objections to the annexation of said lands to the City of Redwood Falls have been received by the City of Redwood Falls from any of the above-named Minnesota Municipal Commission, Town of Honner and County of Redwood.

(c) That the hereinafter described lands abut on the City of Redwood Falls; that said lands are not included in any other municipality; that the petition for annexation of said lands has been signed by all of the owners thereof; and that said lands are unplatted and do not exceed two hundred (200) acres in area.

(d) That the said lands are suitably conditioned for municipal government, and that the annexation thereof to the City of Redwood Falls will be to the best interests of the City of Redwood Falls and of the territory affected.

Section 2. That the following-described real estate lying and being in the Town of Honner, County of Redwood, State of Minnesota, is hereby annexed to the City of Redwood Falls:

TRACT NO. 1: Commencing at the center of Section 31, Township 113 North, Range 35 West, Honner Township, Redwood County, Minnesota, thence South  $89^{\circ}52'$  East and along the North line of the Northwest Quarter of the Southeast Quarter of said Section 31 a distance of 538.57 feet to the point of beginning; thence South  $89^{\circ}52'$  East along the said North line a distance of 794.54 feet to the Northeast corner of the Northwest Quarter of the Southeast Quarter of said Section 31, thence South  $00^{\circ}27'$  West a distance of 1335.87 feet to the Southeast corner of the Northwest Quarter of the Southeast Quarter of said Section 31, thence South  $89^{\circ}57'$  West along the South line of the Northwest Quarter of the Southeast Quarter of said Section 31 a distance of 1273.71 feet, thence North  $66^{\circ}42'$  East a distance of 130.00 feet, thence South  $89^{\circ}57'$  West a distance of 65.000 feet to the West line of the Northwest Quarter of the Southeast Quarter of said Section 31, thence North  $00^{\circ}42'$  East along the said West line a distance of 835.23 feet to the center line of County Highway No. 21, thence North  $33^{\circ}27'$  East along said center line a distance of 124.91 feet, thence North  $29^{\circ}28'$  East along said center line a distance of 143.15 feet, thence North  $89^{\circ}40'$  East a distance of 404.65 feet, thence North  $00^{\circ}20'$  West a distance of 141.81 feet to the point of beginning and containing 38.71 acres more or less.

TRACT NO. 2: The Northeast Quarter of the Southeast Quarter of Section 31, Township 113 North, Range 35 West, Honner Township, Redwood County, Minnesota, except the Southerly 165.00 feet and containing 35.77 acres more or less.

TRACT NO. 3: The Southerly 501.86 feet of the Southeast Quarter of the Northeast Quarter of Section 31, Township 113 North, Range 35 West, Honner Township, Redwood County, Minnesota, and containing 15.36 acres more or less.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and publication.
