AFFIDAVIT OF PUBLICATION

ORDINANCE NO. 45

An Ordinance Extending the Corporate Limits of the Village of Mayer, Carver County, Minnesota to include Certain Lands.

WHEREAS, a petition dated July 28, 1969 requesting annexation of the territory described below was duly presented to the Council on the 28th day of July, 1969;

AND WHEREAS, it appears that the said petition is proper and no objections have been raised during the 30 day waiting period;

THE COUNCIL OF THE VILLAGE OF MAYER, CARVER COUNTY, MINNESOTA ORDAINS:

Section 1. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. The corporate limits of the village are hereby extended to include the territory described as follows:

That part of the Northwest 1/4 of Section 6, Township 116, Range 25, Carver County, Minnesota, described as follows: Commencing at the Northwest corner of said Northwest 1/4; thence east along the north line of said Northwest 1/4 a distance of 333.0 feet; thence south parallel with the west line of said Northwest 1/4 a distance of 1006.6 feet to the Southwest corner of Honebrink's Addition according to the plat thereof on file or of record in the office of the Registrar of Deeds in and for said County; thence east along the south line of said Honebrink's Addition 400.0 feet to the Northeast corner of Honebrink's 2nd Addition according to the plat thereof on file or of record in the office of the Registrar of Deeds in and for said County, said Northeast corner being the actual point of beginning; thence continue east along the south line of said Honebrink's Addition 560.0 feet to the Southeast corner thereof; thence north along the east line of said Honebrink's Addition 175.0 feet to the Northeast corner thereof; thence east along the easterly extension of the north line of said Honebrink's Addition 100.0 feet; thence south parallel with the east line of said Honebrink's 2nd Addition 525.0 feet; thence west parallel with the south line of said Honebrink's Addition 650.0 feet to the Southeast corner of said Honebrink's 2nd Addition; thence north along the east line of said Honebrink's 2nd Addition 350.0 feet to the point of beginning.

Section 3. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Minnesota Municipal Commission, The Carver County Auditor and the office of the Secretary of State of the State of Minnesota.

Section 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3 above.

A. C. WESSALE, being duly sworn, on oath says he is and during all times herein stated has been the publisher and printer of the newspaper known as THE WACONIA PATRIOT and has full knowledge of the facts herein stated as follows: (1) Said newspaper is printed in the English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. (2) Said newspaper is a weekly and is distributed at least once each week. (3) Said newspaper has 50% of its news columns devoted to news of local interest to the community which it purports to serve and does not wholly duplicate any other publication and is not entirely of patents, plate matter and advertisements. (4) Said newspaper is circulated in and near the municipality which it purports to serve, has at least 500 copies regularly delivered to paying subscribers, has an average of at least 75% of its total circulation currently paid or no more than three months in arrears and has entry as second-class matter in its local post-office. (5) Said newspaper purports to serve the City of Waconia in the County of Carver and it has its known office of issue in the City of Waconia in said county, established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by the publisher of said newspaper or persons in his employ and subject to his direction and control during all such regular business hours and at which said newspaper is printed. (6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the publisher of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.
