

ORDINANCE NO, 1516 AN ORDINANCE Annexing to the City of Rechester, Minnesola, Certain Unplatted Land in Cascade Township in the Southwest Quarter of Section Twenty-Four, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesola, THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN: Section 1. The Common Council of the City of Rochester, by written resolution adopted on May 19, 1968, declared its In-fention to annex the following described unplatted land in Cascade Township, Olmsted County, Minnesola, which is more than 75 per cent bordered on three sides by land within the City of Roches-ter: The South Half (St/e) of the South-
