

ORDINANCE NO. 1511 AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land in Cascade Township in the Southeast Quarter of Section Thirty-Two, Township One Hundred Seven North, Range Fourteen West, Oimsted County, Minnesota. THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN: Section 1. The Common Council of the City of Rochester, by written resolution edopted on May 19, 1969, declared its In-tention to annex the following described unplatted Iand in Cascade Township, Oimsted County, Minnesota, which is more than 75 per cent bordered on three sides by land within the City of Roches-fer: That part of the Southeast Quarter

sloes by land within the City of Roches-fer: That part of the Southeast Quarter (S.E. Va), of Section 32, Township 107 north, Range 14 west described as follows: Commencing at the southeast corner of the Southeast Quarter (S.E. Va) of Section 32, Township 107 north, Range 14 west for a place of begin-ning; thence west 330,0 ft.; thence north 396,0 ft.; thence east 330,0 ft.; thence south 396,0 ft, to the place of beginning. The said resolution was thereafter duly served upon the Town Board of Cascade Township, and after said service, sixty days elapsed without objection being filed by the Town of Cascade. Section 2. The quantity of unplatted land included in said resolution is ap-proximately 30, acres. Section 3. The Common Council of the City of Rochester do hereby determines that the lands described in Section 1 abut upon the present territorial limits of the City of Rochester and of the lands affect-ed. Section 4. Therefore, the lands des-cribed in Section 1 above are hereby an-nexed, added to and made a part of the City of Rochester, Minnesota, as effec-tually as If they had originally peen a part thereof. Section 5. Present and future owners of the acea annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the Common Council to assess against benefited property all or a portion of the cord of any sjorm sewer, water fower and frunk line sanitary sewer construc-tion, heretofore or hereafter, undertaken to serve the area annexed. Section 5. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the Common Council to assess against benefited property all or a portion of the cost of any sjorm sewer, water fower and frunk line sanitary sewer construc-tion, heretofore or hereafter, undertaken to serve the area annexed. Section 5. Present and future owners of the aced and eaded to y since annexed; and
