ORDINANCE NO. 1514

AN ORDINANCE Annexing to the City of Rachester, Minnesota, Certain Unitation Thirty-Three, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesota, which is owned by the City of Rochester, Minnesota, TE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The following described unplatited land in Cascade Township, Section 33, Township 107 north, Range 14 west, Olmsted County, Minnesota, is owned by and abuts the municipal limits of the City of Rochester:

A strip of land three hundred (300) feet in width being one hundred fifty (150) feet on each side of the following described centerline:

Beginning on the east boundary of Lof "A" Country City Manor First Addition at a point which is 1771.14 feet north of the south line of Section Thirty-Three (33), Township One Hundred Seven (107) North, Range Fourteen (14) West, thence running due east for a distance of 1677 feet, more or less, measured along the centerline, to the easterly bank of Cascade Creek.


Section 2. The land described in Section 1 above comprising approximately 11.5 acres is hereby annexed, added to and made a part of the City of Rochester, Minnesofa, as effectually as if they had originally been a part thereof.

Section 3. This ordinance shall lake effect and be in force from and after its official publication and from and after the filling of a certified copy thereof with the Minnesofa Mynicipal Commission, the Cascade Town Clerk, The County Auditor and the Secretary of State.
