ORDINANCE NO. 478

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED
TO THE CITY OF NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato, Minnesota, does ordain
as follows:

1. That the following described tracts of land are wholly surrounded
by the municipal boundaries of the City of North Mankato and are hereby
deemed urban in character:

(1) Lot 13, Sunrise Acres Addition No. 4 to the City of
North Mankato, according to the map or plat thereof
on file and of record in the office of the Register
of Deeds, Nicollet County, Minnesota.

(2) Lot 33, Pleasantview Subdivision, City of North
Mankato, according to the map or plat thereof on
file and of record in the office of the Register
of Deeds, Nicollet County, Minnesota.

2. Said above described lands, together with any and all within and
adjacent streets, highways and public rights of way are hereby declared
annexed to and made a part of the City of North Mankato, Nicollet County,
Minnesota, in accordance with Minnesota Statute 414.033, sub. 4.

3. This Ordinance shall take effect from and after its date of passage
and publication.
