ORDINANCE NO. 466

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE
ANNEXED TO THE CITY OF NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato, Minnesota, does ordain
as follows:

1. That the following described tracts of land are wholly surrounded by
the municipal boundaries of the City of North Mankato and are hereby deemed urban
in character:

- (1) Commencing at the Northwest Corner of the Northeast Quarter of the
Southeast Quarter of Section 11, in Township 108, North of Range 27
West; thence running East on the center line of said Section 11,
24 4/10 rods; thence at right angles to said line and running South
parallel to the East line of said Section 11, 24 rods; thence West
and parallel to the center line of said Section 11, 20 rods to the
center of the highway; thence Northerly along the center of said
highway to the center line of said Section 11; thence East 2 rods
to the place of beginning. The same lot being Lot 10 of Pitcher's
Subdivision of the Northeast Quarter of the Southeast Quarter lying
East of the highway in said Section 11, Nicollet County, Minnesota.
- (2) All of the Southeast Quarter of the Northeast Quarter of Section 11,
in Township 108, North of Range 27 West, and all of the Southwest
Quarter of Section 12, in Township 108, North of Range 27 West,
except Sunrise Acres Subdivision No. 5, as recorded in the office
of the Register of Deeds, Nicollet County, Minnesota.
- (3) All of the Northeast Quarter of the Southeast Quarter of Section 11,
in Township 108, North of Range 27 West which lies north of Lee
Boulevard, Nicollet County, Minnesota.
- (4) The South Half of the Southwest Quarter of the Northeast Quarter of
Section 11, in Township 108, North of Range 27 West, except that
parcel of property described as follows: Beginning at the South-
east corner of the Southwest Quarter of the Northeast Quarter of
Section 11; thence North 125 feet along the center line of County
Aid Road No. 13; thence West 660 feet; thence South 125 feet; thence
East along the center line of Lee Boulevard to the point of beginning.

2. Said above described lands together with any and all within and adjacent
streets, highways and public rights of way are hereby declared annexed to and
made a part of the City of North Mankato, Nicollet County, Minnesota, in accordance
with Minnesota Statute 414.03, sub. 2.

3. This Ordinance shall take effect from and after its date of passage
and publication.

ORDINANCE NO. 479

AN ORDINANCE AMENDING ORDINANCE NO. 466 (Attached)
DECLARING CERTAIN PLATTED LAND TO BE ANNEXED
TO THE CITY OF NORTH MANKATO

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:

Section 1. That Ordinance No. 466, annexing certain land to the City of North Mankato, Sec. 1 (2) thereof be amended to read as follows:

"(2) All of the Southeast Quarter of the Northeast Quarter of Section 11, in Township 108, North of Range 27 West, and all of the Southwest Quarter of the Northwest Quarter of Section 12, in Township 108, North of Range 27 West, except Sunrise Acres Subdivision No. 5, as recorded in the office of the Register of Deeds, Nicollet County, Minnesota."

Section 2. This Ordinance shall take effect from and after its date of passage and publication.
