ORDINANCE NO. 233

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. The following described tract of land is wholly owned by the City, said tract is non-agricultural and is suitable for urban purposes:

Commencing at the southwest corner of the Northeast quarter of the Southeast quarter (NE<sup>1</sup>/<sub>4</sub> of SE<sup>1</sup>/<sub>4</sub>), thence North 620 feet; thence east 33 feet; thence south 620 feet; thence west 33 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing parcel and bounded as described is approximately one-half (1/2) acre and abuts on the present city limits along the north line of said tract and at the southwest corner where it abuts on Twelfth Street at the northeast corner of Block One (1) of Searles First Addition.

Section 3. The City Council determines that the annexation will be to the best interests of the City of Staples, Minnesota and of the property affected and is so conditioned as properly to be subject to city government and is authorized by Minnesota Statute 414.03, Subdivision 2.

Section 4. Therefore, the City of Staples hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after the filing of certified copies thereof with the Minnesota Municipal Commission, the County Auditor, the Secretary of State of Minnesota, the Todd County Register of Deeds and from and after its passage and publication.

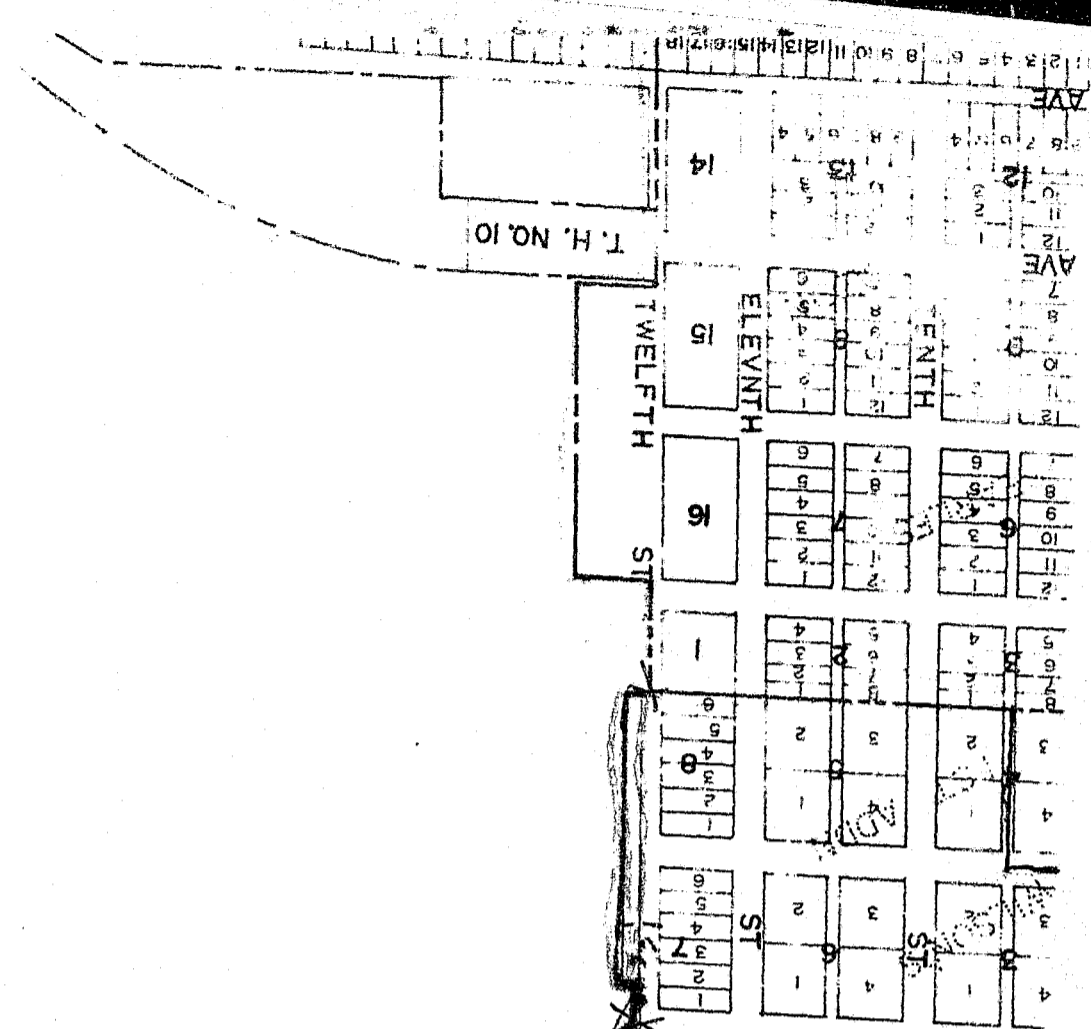
