ORDINANCE NO. 351

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF
HUTCHINSON, McLEOD COUNTY, MINNESOTA

The City of Hutchinson ordains:

SECTION I. WHEREAS, the City of Hutchinson is the owner of the following described lands lying and being in the County of McLeod and State of Minnesota and described as follows, to-wit:

The West 30.0 feet of the Northwest $\frac{1}{4}$ acre of Lot 6 of the Auditor's Plat of the South Half of Section 30 and the North Half of Section 31, Township 117 North, Range 29 West.

Also the West 30.0 feet of the following described tract lying in Lot 6 of the Auditor's Plat of the South Half of Section 30 and North Half of Section 31, Township 117 North, Range 29 West; Beginning at the Northwest corner of said Lot 6; thence due South along the West line of said Lot 6, 136 feet to the point of beginning; thence continuing South along the West line, 33 feet; thence Easterly on a line parallel with the North line of said Lot 6, 104 feet; thence due North on a line parallel with the West line of said Lot 6, 33 feet; thence Westerly on a line parallel with the North line of said Lot 6, 104 feet; to the point of beginning.

A part of Lot Six (6) of the Auditor's Plat of the South Half ($S\frac{1}{2}$) of Section 30 and the North Half ($N\frac{1}{2}$) of Section 31, Township 117 North, Range 29 West, McLeod County, Minnesota, and more particularly described as follows:

Beginning at a point on the West line of said Lot Six (6), said point being 660 feet South of the Northwest corner of said Lot Six (6), thence South on the west line of said Lot Six (6) to the Northwest corner of Hillcrest Second Addition, thence east on the North line of Hillcrest Second Addition, 30.00 feet, thence North, parallel to the West line of said Lot six to a point 30.00 feet East of the point of beginning, thence west to the point of beginning.

A part of Lot Six (6) of the Auditor's Plat of the South Half ($S\frac{1}{2}$) of Section 30 and the North Half ($N\frac{1}{2}$) of Section 31, Township 117 North, Range 29 West, McLeod County, Minnesota, and more particularly described as follows:

Commencing at the Northwest corner of said Lot 6, thence South 384 feet on the West line of said Lot 6, thence East 30.0 feet to the point of beginning of the tract; thence South 20.0 feet parallel to the West line of said Lot 6; thence East 204.00 feet parallel to the North line of said Lot 6; thence North 20.0 feet parallel to the West line of said Lot 6; thence West 204.0 feet parallel to the North line of said Lot 6, to the point of beginning.

SECTION II. WHEREAS, the City Council of the City of Hutchinson deems it desirable and in the best interest of the City of Hutchinson to annex the above described lands to the City of Hutchinson.

SECTION III. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hutchinson that the lands described above be and they hereby are

annexed to the City of Hutchinson and from and after the date of passage of this Ordinance, said lands shall become a part and portion of the City of Hutchinson with the same force and effect as though originally a part of the City.

SECTION IV. This Ordinance shall take effect and be in force from and after its publication.
