

AN ORDINANCE EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF MANKATO TO  
INCLUDE CERTAIN UNPLATTED LANDS, NOT  
EXCEEDING TWO HUNDRED ACRES, ABUTTING  
UPON THE CITY OF MANKATO LIMITS.

The City of Mankato, Minnesota, does ordain:

I.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota by O. P. Confer and R. J. Lloyd, as owners of the following described property, to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

That part of the East One Half of the Northwest Quarter of Section 30, Township 108 North, Range 26 West, described as follows: Commencing at the Northeast Corner of the East One Half of the Northwest Quarter of said Section 30, thence South 0°-00', (assumed bearing) along the East line of the East One Half of the Northwest Quarter of Said Section 30, 782.00 feet to the point of beginning, Said point being the Southeast Corner of Lot 22, Viking Terrace Addition to the City of Mankato, Blue Earth County, Minnesota, thence South 90°-00' West along the South line of said Viking Terrace Addition, 295.00 feet, thence North 51°-00' West along the Southerly line of said Viking Terrace Addition, 380.00 feet, thence South 90°-00' West along the South line of said Viking Terrace Addition 590.10 feet to the Southwest Corner of Lot 35 of said Viking Terrace Addition, thence South 0°-03'-42" East, 190.00 feet, thence South 90°-00' West, 60.00 feet, thence South 0°-03'-42" East, 130.00 feet, thence North 90°-00' East 484.00 feet, thence South 77°-41'-06" East, 64.20 feet, thence South 54°-48'-48" East, 64.20 feet, thence South 51°-00' East, 256.00 feet, thence South 64°-30' East, 130.00 feet, thence South 81°-04'-36" East, 136.30 feet, thence North 0°-00' and parallel with the East line of the East One Half of the Northwest Quarter of said Section 30, 110.00 feet, thence North 90°-00' East, 190.00 feet to a point on the East line of the East One Half of the Northwest Quarter of said Section 30, thence North 0°-00' along said East line 260.00 feet, to the point of beginning.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the southerly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000 pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato

Township Town Board, and the Blue Earth County Board, and that the thirty day period as provided for by Section 414.03 of M.S.A., Subdivision 2, and the Rules of the Municipal Commission, having been duly waived by the Mankato Township Board, Blue Earth County Board, and the City of Mankato, and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts or parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

IV.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance shall take effect ten (10) days after the date of its passage and publication and upon the filing of certified copies, as herein described.
