ORDINANCE NO. 356

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND RORMERLY LOCATED IN THE TOWNSHIP OF HUTCHINSON

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Floyd and Fern Servin, Robert W. and Donna Phillips, and Dorothy and Leslie Ogren, being sole owners of the following described real property, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

Lots four (4) and five (5) and fifteen (15) Ahrens Highland Park Subdivision.

<u>Section II.</u> The quantity of land embraced within the foregoing description and bounded as described, is three (3) lots.

Section III. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section IV. Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section V. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
