ORDINANCE NO. 84 The Council of the Village of Elk River, Minnesota, do ordain as follows: Section 1. That the following de-scribed real estate situated in the county of Sherburne, State of Minne-sota, and described as follows, to-wit: That part of the Southwest Quarter ter of the Southwest Quarter (28), Township 33, Range 26, that lies Northerly of the 'rail-road right-of-way running from-Elk River to Big Lake and South-way running from Elk River to Princeton.
