Ordinance No. 5/3

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota.

WHEREAS, A petition has been filed with the City of Willmar, Minnesota, seeking the annexation to said City of the following described lands:

Northwood Estates according to the recorded plat thereof on file and of record in the office of the Register of Deeds of Kandiyohi County, Minnesota, and the South Half of the Southwest Quarter of Section 3, Township 119, Range 35, except that part thereof contained within the plat of said Northwood Estates.

WHEREAS, The City Council of the City of Willmar, Minnesota, determines and finds that the annexation of said territory will be to the best interests of the City of Willmar and of the territory affected,

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar, Minnesota as follows:

Section 1. Annexation. The property described above is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Section 2. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as properly to be subject to City government.

Section 4. Zoning. The area above described shall be zoned R1 Residential.

Section 5. Effective Date. This ordinance shall take effect and be in full force from and after filing a copy hereof with the Minnesota Municipal Commission, the Clerk of the Township of Willmar, the Kandiyohi County Auditor, and the Secretary of State of Minnesota.
