ORDINANCE NO. 343

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS all of the owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

Beginning at the intersection of the centerline of Pine Avenue and the centerline of the alley between Lots 4 and 5 of Forsbergs Rearrangment of Park Addition; thence North along the centerline of said Pine Avenue to the southerly bank of the Red Lake River, thence Northeasterly along a line perpendicular to said bank to the center of the Red Lake River; thence Southeasterly along the center of said River to an intersection with a north-south line which is the East line extended of the west 35' of Lot 1 of Block 4 of Park Addition to Thief River Falls; thence South along said east line to the centerline of a vacated street between Lots 2 of Block 4 and Lot 5 of Block 5 all in said Park Addition; thence West along the centerline of said vacated street to an intersection with the centerline of a natural waterway which is the west boundary of said Lot 2 of Block 4; thence Northerly along the centerline of said waterway to an intersection with the centerline of the alley between Lots 4 and 5 of said Forsbergs Rearrangement extended; thence West along the centerline of said alley to the point of beginning; containing 3.9 acres more or less,

have petitioned the City Council to have such land included within the municipality and have filed copies of said petition with the Municipal Commission of the State of Minnesota, with the Town Board of the Township of North and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS the above described property abuts upon the boundaries of the City of Thief River Falls and

WHEREAS no objections to the proposed annexation have been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Pennington County Auditor and the Secretary of State of the State of Minnesota.



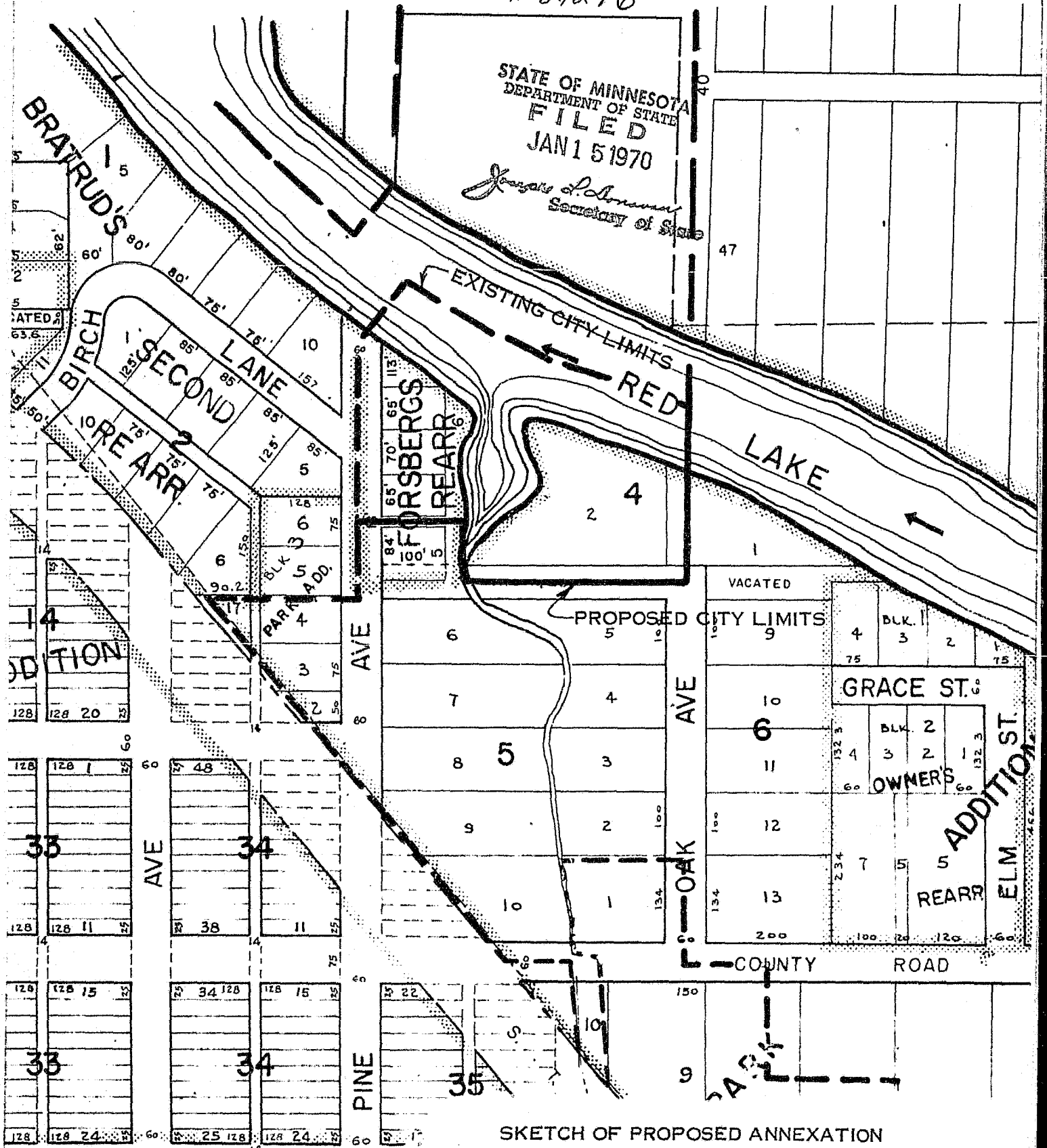
