ORDINANCE NO. 259

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ST. PETER TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND CONTAINING 41.5 ACRES MORE OR LESS.

The Common Council of the City of St. Peter, Minnesota, does ordain:

Section 1. An application for annexation has been filed with the governing body of the City of St. Peter, Minnesota, by all of the land owners in area and number of the following described real estate to have such properly included within the City of St. Peter, Minnesota:

Esginning at the West Quarter Corner of Sertion Nine (9), Township One Hundred Ten (110) North, Renge Twenty-Six (26) West, thence due East along the North line of the Southwest Quarter of said Section Nine (9), a distance of 1461.59 feet; thence South 12 degrees 39.5 minutes east, 1502.98 feet, thence South 77 degrees 20.5 minutes west, 331.27 feet to the northerly right of way line of Minnesota Trunk Mighway No. 22, thence North 56 degrees 57.5 minutes west along the northerly right of way line of said Highway, a distance of 1770.9 feet to the West line of the Southwest Quarter of said Section Nine (9), thence North 1 degree 40.5 minutes East along the West line of the Southwest Quarter of said Section Nine (9), a distance of 573.7 feet to the point of beginning.

"Plus that portion of Minnesota Trunk Highway No. 22 located in the Southwest Quarter of Section Nine (9), Township One Hundred Ten (110) North, Range Twenty-Six (26) West which abuts the above described property."

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, contains 41.5 acres of land more or less.

Section 3. The area proposed for americation is unplatted.

Section 4. An affidavit has been filed with the City Clerk's Office stating that espies of the Petition for Ameration have been filed with the Minnesota Municipal Commission, the Town Board, and County Board of the Town and County in which all or part of the land to be annexed is located. More than 60 days has elapsed since said filing without objections to said annexation being received by the City of St. Peter.

Sertion 5. The amenation will be to the best interests of the City of St. Peter.

Section 6. The corporate limits of the City of St. Peter are hereby extended to include the property described in Section 1 and the same is horeby annexed to and included within the City as effectively as if it had originally been a part thereof.

Section 7. The City Clerk is hereby directed to file certified copies of this oxdinance with the Minnesota Municipal Countssion, the Secretary of State and the Nicollet County Auditor.

Section 8. This ordinance takes effect upon its passage, approval, publication and the filing of the certified capies as directed in Section 7.
