ORDINANCE NO. 194

AN ORDINANCE RELATIVE TO THE ANNEXATION OF  
AND ANNEXING CERTAIN LANDS TO THE CITY OF  
REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

Section 1. That it is hereby found, determined and declared that the real estate described in Section 2. hereof is completely surrounded by land within the municipal limits of the City of Redwood Falls.

Section 2. That the following-described real estate lying and being in the Township of Honner, County of Redwood, State of Minnesota, is hereby annexed to the City of Redwood Falls:

TRACT A. Commencing at the center of Section Thirty One (31), Township One Hundred Thirteen (113) North, Range Thirty Five (35) West, and running thence South  $89^{\circ}52'$  East along the North line of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of said Section Thirty One (31) a distance of 216.82 feet to the point of beginning, running thence South  $89^{\circ}52'$  East along said North line a distance of 321.75 feet; thence South  $00^{\circ}20'$  East a distance of 111.61 feet; thence South  $89^{\circ}40'$  West a distance of 404.65 feet to the center line of Redwood County Highway No. 21; thence North  $29^{\circ}23'$  East along the center line of said highway a distance of 166.98 feet to the place of beginning.

TRACT B. Commencing at the Southeast corner of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty One (31), Township One Hundred Thirteen (113) North, Range Thirty Five (35) West, and running thence West along the Southline of said Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty One (31), South  $89^{\circ}57'$  West a distance of 1273.71 feet to the place of beginning, running thence North  $00^{\circ}42'$  East a distance of 130 feet, thence South  $89^{\circ}57'$  West a distance of 65 feet, thence South along the West line of said Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty One (31) a distance of 130 feet to the Southwest corner of said Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty one (31), thence East along the South line of said Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty One (31), a distance of 65 feet to the place of beginning.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and publication.
