CHAPTER XV

ORDINANCE NO. 150 - M.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED ON THREE SIDES BY LAND WITHIN THE VILLAGE LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is seventy-five percent bordered on three sides by lands already included within the corporate limits of the village and is deemed to be urban in character; and

WHEREAS a Notice of Intent to Annex said lands was served upon the Town Board of Le Sauk Township on the 4th day of September, 1969;

THE VILLAGE COUNCIL OF SARTELL ORDAINS AS FOLLOWS:

Section 1. Territory Annexed. The corporate limits of the Village of Sartell, Minnesota are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been seventy-five percent bordered on three sides by territory already included within the Village limits, to-wit:

"The Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$); The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$); and, the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-Eight (28), Township One Hundred Twenty-Five (125) North, Range Twenty-Eight (28) West, Stearns County, Minnesota, containing 120 acres, more or less."

Section 2. Filing. The Village clerk is directed to file certified copies of this Ordinance with the Secretary of State, the Stearns County Auditor and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This Ordinance takes effect upon passage and publication and the filing of the certified copies as directed herein.

Adopted by the Village Council of Sartell, Minnesota, by unanimous vote thereof at regular meeting thereof on the 17th day of November 1969.
