ORDINANCE NO. 480

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED
TO THE CITY OF NORTH MANKATO, MINNESOTA

The Common Council of the City of North Mankato, Minnesota, does ordain
as follows:

1. That the following described tract of land is 60% or more surrounded
by the municipal boundaries of the City of North Mankato and is hereby deemed
urban in character:

That certain tract of land all within Nicollet County and
lying southerly of the north right of way line of Minnesota
Trunk Highway 14 between the east line of the northwest
quarter of the northwest quarter of Section 14, Township
108 North, Range 27 West, and the east line of said
Section 14, excepting therefrom Len Al Acres Addition to
the City of North Mankato, according to the map or plat
thereof on file and of record in the office of the Register
of Deeds in and for Nicollet County. Said tract shall
include any and all streets, highways, navigable streams
or other public rights of way within and adjacent to said
described land.

2. Said above described land is hereby declared annexed to and made a
part of the City of North Mankato, Nicollet County, Minnesota, in accordance with
Minnesota Statute 414.033, sub. 3.

3. This Ordinance shall take effect from and after its date of
passage and publication.
