AN ORDENANCE ENTENDED THE CORPORATE LIMITES OF THE VILLAGE OF LONG PRANCIE TO RECLEME GERTAIN UNINCORPORATED, INFLATED LAND APLITTING DPCH THE VILLAGE LIMITS.

CARRENEAS, a cortain patition, dated October 1, 1969, requesting canonation of the territory horeinatter described was duly presented to the Council on the Let day of October, 1969, and

WHENCAS, the quantity of land embraced with the area desurfled in do position and bounded on described is less than two hundred (200) acros of unplated land, being approximately four (4) cares, no part of which is included within the limits of an incorporated sity, village or bureuph, and

WHEREAS, the pathlon was signed by all of the evenese of sold property, and

WHEREAS. no objections to the announcion have been received from the town heard, the county board, or the governing budy of any municipality where houndaries abut upon the land to be announced, and

WHEREAS, a copy of cald petitin was filed with the Municipal Commission of the Store of Minnesote, the County Auditor of Fodd County, and the Town Clerk of Long Proteic Township, on Science 18, 1969, and

WIENERS, the land described in the polition alons upon the Village limits at the same loundary thereof

The Council of the Villege of Long Prairie, Minnesota, ordains:

Section 1. The Village Council hereby determines:

- (a) That the amenation will be to the lest interests of the Village, and of the territory affected.
- (b) That the carritory described herein abute upon the Village limits and is orban or culturban in character.
- (c) That none of the territory is now included within the limits of any sity, village or horough.

Section 2. Territory America. The corporate limits of the Village are horeby entended to include the unplatted land described up follows, and the came to hereby amoned to and menulat in the Villago as effectually as if it had ariginally been a part thoreof.

A part of the South flatt of the Southwest Quartor (%) of SWA) of Section Twenty (30), Township One Hundred Twenty-nine (129) North, Range Thirty-three (83), described as follows, ro-wit Commensing at the Southeast curver of Los Seventeen (17), Fleck Two (2), Lee's Addition To the Village of Long Prairie, chence south 220 feet, chence west to the railread right-of-voy, thence particestorly along the said railread right-of-way to the Southwest corner of said Lot Seventeen (17), theneo east along the south live of said Lot Seventeen (17) to the point of beginning, containing approximately 4 acres, more or less.

Sector 9. Filing. The Village Clork is hereby directed to sile certified copies of this ordinance with the Manassia Musicipal Commission, the Sebretary of State and the County Auditor.

Section 4. Effective Cate. This ordinance takes effect upon its pescage and publication and filing of the certifics copies as directed in Section 3.
