ORDINANCE NO. 97

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS

WHEREAS, a certain petition dated September 26, 1969, requesting annexation of certain territory hereinafter described was duly presented to the Council on the 27th day of September, 1969, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 8 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WHEREAS, the land described in the petition abuts upon the Village limits at the southerly boundary thereof; and

WHEREAS, copies of said Petition have been filed with the Municipal Commission, the Town Board of the Town of Chisago Lake; and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be annexed is located, and

WHEREAS, the boundaries of no other municipality abut upon the boundaries of the land to be so annexed, and

WHEREAS, no written objections to said annexation have been submitted to the Municipal Commission or the Village of Lindstrom by the Chisago Lake Town Board or the Chisago County Board of Commissioners within sixty (60) days after said filing and the time allowed pursuant to law, and

WHEREAS, no petition for incorporation or annexation is pending before the Municipal Commission including all or any part of the land proposed to be annexed and herein described;

The Council of the Village of Lindstrom, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village Limits and is urban in character; and (3) that none of said territory is now included within the limits of any incorporated city, village, or borough, is unplatted and does not exceed 200 acres in area.

Section 2. Territory Annexed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

Lot Six (6), except the South 759 feet and the North 200 feet thereof, Section Thirty-three (33), Township Thirty-four (34), Range Twenty (20), Chisago County, Chisago Lakes Township, Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the Town Clerk and County Auditor of Chisago County, Minnesota.
