

ORDINANCE NO. 127

AN ORDINANCE EXTENDING THE CORPORATE LIMITS ^{ABUTTING} OF THE CITY OF BENSON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY ~~WITHIN~~ THE CITY LIMITS AND ~~ADJACENT TERRITORY~~ OWNED IN FEE BY THE CITY OF BENSON, MINNESOTA.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporate city, village, or borough; and

WHEREAS, this territory is owned in fee by the City of Benson, Minnesota and is deemed to be urban in character;

The City of Benson does ordain:

\ Section 1. Territory Annexed. The corporate limits of the City of Benson, Minnesota, are hereby extended to include the unincorporated territory described as follows, which territory now is and has heretofore been owned in fee by the City of Benson, Minnesota:

AREA 1.

Part of the Northeast Quarter (NE $\frac{1}{4}$) of Section One (1), T121N, R40W, Swift County, Minnesota, described as follows:

Commencing at the Northeast corner of Section One, T121N, R40W; thence West along the North line of Section One to a point which is 414.5 feet East of the centerline of Trunk Highway Number Nine (T. H. #9); thence deflect to the left, 130° 18' in a southeasterly direction for a distance of 814.6 feet; thence; thence deflect to the left 86° 10' for a distance of 141.0 feet; thence bearing South 43° 50' West a distance of 541 feet to the centerline of Trunk Highway No. 9; thence along the centerline of Trunk Highway No. 9 in a southeasterly direction to a point where such line intersects the West line of Section One; thence North along the West line of Section One to the point of beginning, containing ~~15~~ 15 acres more or less.

Commencing at the Northwest corner of Section Six (6), T121N, R39W; thence easterly along the Northline of Section Six for 1510.81 feet to the Northeast corner of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ -NW $\frac{1}{4}$) of Section Six; thence South for a distance of 1486.97 feet along the east line of the West one half (W $\frac{1}{2}$) of the Northwest Quarter of Section Six; thence North 67° 09' West for 133 feet; thence South 22° 51' West for a distance of 540 feet to the centerline of Trunk Highway No. 9; thence North 67° 09' West a distance of 70 feet along the centerline of Trunk Highway No. 9; thence North 22° 51' East a distance of 540 feet; thence North 67° 09' West for a distance of 300 feet; thence South 22° 51' West a distance of 150 feet; thence North 67° 09' West a distance of 301.5 feet; thence at a 90 degree angle to the left for a distance of 391.5 feet to the centerline of Trunk Highway No. 9; thence northwesterly along the centerline of Trunk Highway No. 9 a distance of 621 feet to the West line of the Northwest Quarter of Section Six; thence North along the West line of the Northwest Quarter (NW $\frac{1}{4}$) of Section Six 1464 feet to the point of beginning, containing ⁵² 52 acres more or less.

AREA III.

Part of the East 1/2 of the Northwest 1/4 of Section Six, T121N, R39W, Swift County, State of Minnesota, described as follows:

No. 9 to the East bank of the Chippewa River (Judicial Ditch No. 19) a distance of 482.15 feet; thence North 25° 00' East along a meander line representing the East bank of Judicial Ditch No. 19 (Chippewa River) a distance of 195.0 feet; thence North 03° 02.25' East a distance of 228.7 feet; thence North 17° 49.75' West for 225.95 feet; thence North 29° 40' West for 481.25 feet; thence North 15° 23.75' West for 184.27 feet; thence North 04° 55' East for 180.83 feet; thence North 06° 55.75' East for 928.20 feet to a point on the North line of the Northwest Quarter of Section 6; thence North 88° 36.5' West a distance of 475.91 feet to the point of beginning, containing 22 acres more or less.

AREA IV

All of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ -SW $\frac{1}{4}$) of Section Thirty-one (31); T122N; R39W; Swift County, Minnesota except therefrom a parcel of land containing 7 acres more or less, described as follows:

Commencing at a point 99 feet West of the Southeast corner of the Southwest Quarter of Section Thirty-one; thence North eighty rods to the North line of the Southeast Quarter of the Southwest Quarter; thence West 14 rods (131 feet) along the North line; thence South eighty rods to the South line of the Southeast Quarter of the Southwest Quarter; thence East 131 feet to the point of beginning containing 7 acres more or less.

AREA V

A parcel of land in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section 31, T122N, R39W, Swift County, Minnesota, described as follows:


